## **SENATE BILL No. 325**

March 14, 2001, Introduced by Senators HAMMERSTROM, NORTH, YOUNG, SMITH, SHUGARS, SCHWARZ, BYRUM, JOHNSON and DUNASKISS and referred to the Committee on Health Policy.

A bill to amend 1978 PA 368, entitled "Public health code,"

by amending sections 16186 and 16263 (MCL 333.16186 and 333.16263), section 16186 as amended by 1993 PA 80 and section 16263 as amended by 2000 PA 11, and by adding section 16338 and part 186.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 16186. (1) An individual who is licensed to practice a
- 2 health profession in another state or who is registered in
- 3 another state or who holds specialty certification from another
- 4 state and who applies for licensure, registration, or specialty
- 5 certification in this state may be granted an appropriate license
- 6 or registration upon satisfying the board or task force to which
- 7 the applicant applies as to all of the following:

- 2 this article and rules promulgated by a board or task force for
- 3 licensure, registration, or specialty certification.
- 4 (b) The applicant is licensed, registered, or certified in

- 7 (2) Before licensing, registering, or certifying the appli-
- 8 cant, the board or task force to which the applicant applies may
- 9 require the applicant to appear personally before it for an
