

# SENATE BILL No. 374

March 29, 2001, Introduced by Senators BULLARD, DUNASKISS, MC COTTER, SIKKEMA, NORTH, JOHNSON and HAMMERSTROM and referred to the Committee on Transportation and Tourism.

A bill to amend 1927 PA 175, entitled  
"The code of criminal procedure,"
