May 10, 2001, Introduced by Senators BENNETT, YOUNG, STEIL, GARCIA, MC COTTER, HAMMERSTROM, SHUGARS, SIKKEMA and GOSCHKA and referred to the Committee on Judiciary.

"The code of criminal procedure,"

by 2000 PA 459.

CHAPTER XVII

Sec. 12. This chapter applies to the following felonies
enumerated in chapters 200 to 299 of the Michigan Compiled Laws:
