## **SENATE BILL No. 611**

July 11, 2001, Introduced by Senator HAMMERSTROM and referred to the Committee on Economic Development, International Trade and Regulatory Affairs.

A bill to amend 1978 PA 368, entitled "Public health code,"

by amending section 16263 (MCL 333.16263), as amended by 2000 PA 11, and by adding section 16336 and part 179.

- 26 PERIOD AFTER THE EFFECTIVE DATE OF THE AMENDATORY ACT THAT ADDED
- 27 THIS PART, SUBMISSION TO THE DEPARTMENT OF PROOF OF SATISFACTORY

- 6 WITH HIS OR HER APPLICATION FOR REGISTRATION RENEWAL PROOF SATIS-
- 7 FACTORY TO THE DEPARTMENT OF BOTH OF THE FOLLOWING:
- 8 (A) THAT HE OR SHE HAS SUCCESSFULLY COMPLETED A COURSE OF
- 9 TRAINING IN FIRST AID, CARDIOPULMONARY RESUSCITATION, AND FOREIGN
- 10 BODY OBSTRUCTION OF THE AIRWAY APPROVED BY THE DEPARTMENT AND
- 11 OFFERED OR APPROVED BY THE AMERICAN RED CROSS, THE AMERICAN HEART
- 12 ASSOCIATION, OR A COMPARABLE ORGANIZATION.
- 13 (B) THAT HE OR SHE HOLDS, AT THE TIME OF APPLICATION FOR
- 14 RENEWAL AND AT ALL TIMES DURING THE PREVIOUS REGISTRATION PERIOD,
- 15 A VALID CERTIFICATION IN FIRST AID AND CARDIOPULMONARY RESUSCITA-
- 16 TION ISSUED BY THE ORGANIZATION OFFERING THE TRAINING.
- 17 SEC. 17907. THIS PART DOES NOT REQUIRE NEW OR ADDITIONAL
- 18 THIRD PARTY REIMBURSEMENT FOR SERVICES RENDERED BY AN INDIVIDUAL
- 19 REGISTERED UNDER THIS PART.
