- 20 (3) THE DEPARTMENT MAY ISSUE A NONRENEWABLE TEMPORARY AUTHO-
- 21 RIZATION FOR A MAGNETIC RESONANCE IMAGER IF ADDITIONAL TIME IS
- 22 NEEDED TO ALLOW SUBMISSION OF EVIDENCE SATISFACTORY TO THE
- 23 DEPARTMENT THAT THE MAGNETIC RESONANCE IMAGER, THE PERSONNEL
- 24 OPERATING THE MAGNETIC RESONANCE IMAGER, AND THE FACILITY IN

- 22 (7) THE DEPARTMENT MAY WITHDRAW THE AUTHORIZATION FOR A MAG-

- 24 DARDS SET FORTH IN SUBSECTION (2).
- 25 (8) THE DEPARTMENT SHALL PROVIDE AN OPPORTUNITY FOR A HEAR-
- 26 ING IN CONNECTION WITH A DENIAL OR WITHDRAWAL OF AUTHORIZATION
- 27 UNDER THIS SECTION.

- 1 (9) UPON FINDING THAT A DEFICIENCY IN A MAGNETIC RESONANCE
- 2 IMAGER OR A VIOLATION OF THIS PART OR THE RULES PROMULGATED UNDER
- 3 THIS PART SERIOUSLY AFFECTS THE HEALTH, SAFETY, AND WELFARE OF

- 7 SHALL INCORPORATE ITS FINDINGS IN THE ORDER AND SHALL PROVIDE AN
- 8 OPPORTUNITY FOR A HEARING WITHIN 5 WORKING DAYS AFTER ISSUANCE OF
- 9 THE ORDER. THE ORDER IS EFFECTIVE DURING THE PROCEEDINGS.
