December 5, 2001, Introduced by Senators HART, MURPHY, PETERS, DINGELL, KOIVISTO, SCOTT and YOUNG and referred to the Committee on Economic Development, International Trade and Regulatory Affairs.

A bill to amend 1931 PA 328, entitled "The Michigan penal code,"

(MCL 750.1 to 750.568) by adding section 141b.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 141B. (1) A PERSON SHALL NOT SELL OR PROVIDE AN ADMIT-

- 7 17 YEARS OLD IS ACCOMPANIED TO THE R-RATED FILM BY HIS OR HER
- 8 PARENT OR GUARDIAN.
- 9 (2) AN OPERATOR SHALL POST A CONSPICUOUS NOTICE THAT
- 10 CONTAINS ALL OF THE FOLLOWING AT EACH MOTION PICTURE THEATER
- 11 FACILITY ENTRANCE AND EACH MOTION PICTURE THEATER ENTRANCE:

- 13 PROOF OF AGE FROM A PROSPECTIVE MOTION PICTURE TICKET PURCHASER
- 14 OR INDIVIDUAL IN THE MOTION PICTURE THEATER.
- 15 (4) IF A VIOLATION OF SUBSECTION (1) OCCURS AT A MOTION PIC-
- 16 TURE THEATER FACILITY, THE OPERATOR MAY BE FOUND GUILTY OF THE
- 17 VIOLATION, EVEN IF THE OPERATOR WAS NOT THE PERSON WHO SOLD OR
- 18 PROVIDED A TICKET TO OR WHO ADMITTED AN INDIVIDUAL UNDER THE AGE

- 20 (5) AN OPERATOR OR OTHER PERSON THAT VIOLATES SUBSECTION (1)

- 22 MEANOR PUNISHABLE AS FOLLOWS:
- (A) FOR A FIRST VIOLATION, BY A FINE OF \$250.00.
- 24 (B) FOR A SECOND VIOLATION OCCURRING WITHIN 12 MONTHS OF THE
- 25 FIRST VIOLATION, BY A FINE OF \$500.00.

- 1 (C) FOR A THIRD OR SUBSEQUENT VIOLATION OCCURRING WITHIN 12
- 2 MONTHS OF THE MOST RECENT PRIOR VIOLATION, BY A FINE OF
- **3** \$1,000.00.
- 4 (6) IT IS AN AFFIRMATIVE DEFENSE TO A PROSECUTION FOR A VIO-
- 5 LATION OF SUBSECTION (1) THAT THE INDIVIDUAL UNDER 17 YEARS OLD
- 6 PRESENTED PHOTO IDENTIFICATION AS PROOF OF AGE THAT WOULD HAVE
- 7 LED A REASONABLE PERSON TO BELIEVE THAT THE INDIVIDUAL UNDER THE
- 8 AGE OF 17 WAS 17 YEARS OLD OR OLDER.
- 9 (7) SUBJECT TO SUBSECTION (8), IT IS AN AFFIRMATIVE DEFENSE
- 10 TO A PROSECUTION OF AN OPERATOR FOR A VIOLATION OF SUBSECTION (1)
- 11 THAT, BEFORE THE DATE OF THE ALLEGED VIOLATION, THE OPERATOR
- 12 ADOPTED AND ENFORCED A WRITTEN POLICY THAT REFLECTS THE OBLIGA-
- 13 TIONS OF AN OPERATOR AND OTHER PERSONS DESCRIBED IN THIS SECTION
- 14 AND DID ALL OF THE FOLLOWING:
- 15 (A) INFORMED ALL EMPLOYEES OF THE WRITTEN POLICY.
- 16 (B) REQUIRED EMPLOYEES TO SIGN A FORM INDICATING THAT THEY
- 17 HAD BEEN INFORMED OF AND UNDERSTOOD THE WRITTEN POLICY.
- 18 (C) REQUIRED EMPLOYEES TO VERIFY THE AGE OF TICKET BUYERS
- 19 AND HOLDERS IN ACCORD WITH THE WRITTEN POLICY.
- 20 (D) ESTABLISHED AND ENFORCED DISCIPLINARY SANCTIONS FOR NON-
- 21 COMPLIANCE WITH THE WRITTEN POLICY.
- 22 (8) AN OPERATOR MAY NOT ASSERT THE AFFIRMATIVE DEFENSE
- 23 DESCRIBED IN SUBSECTION (7) IN MORE THAN 2 PROSECUTIONS FOR VIO-
- 24 LATIONS OF SUBSECTION (1) WITHIN ANY 12-MONTH PERIOD.
- 25 (9) AS USED IN THIS ACT:
- 26 (A) "MOTION PICTURE THEATER" MEANS A ROOM OR ENCLOSURE IN
- 27 WHICH A MOTION PICTURE IS SHOWN.

- 1 (B) "MOTION PICTURE THEATER FACILITY" MEANS A BUILDING OR
- 2 PART OF A BUILDING THAT CONTAINS 1 OR MORE MOTION PICTURE THE-
- 3 ATERS AND AREAS USED FOR RELATED ACTIVITIES, IF ANY, INCLUDING,
- 4 BUT NOT LIMITED TO, LOBBIES, TICKET SALES AREAS, OR CONCESSION
- 5 STANDS.
- 6 (C) "NC-17-RATED MOTION PICTURE" MEANS A MOTION PICTURE
- 7 RATED NC-17 BY THE FILM RATING BOARD OF THE CLASSIFICATION AND
- 8 RATING ADMINISTRATION SPONSORED BY THE MOTION PICTURE ASSOCIATION
- 9 OF AMERICA AND THE NATIONAL ASSOCIATION OF THEATRE OWNERS.
- 10 (D) "OPERATOR" MEANS THE OWNER, PROPRIETOR, FRANCHISEE,
- 11 OPERATOR, MANAGER, OR OTHER PERSON IN CHARGE OF A MOTION PICTURE
- 12 THEATER FACILITY.
- 13 (E) "R-RATED MOTION PICTURE" MEANS A MOTION PICTURE RATED R
- 14 BY THE FILM RATING BOARD OF THE CLASSIFICATION AND RATING ADMIN-
- 15 ISTRATION SPONSORED BY THE MOTION PICTURE ASSOCIATION OF AMERICA
- 16 AND THE NATIONAL ASSOCIATION OF THEATRE OWNERS.
