

# SENATE BILL No. 1045

January 30, 2002, Introduced by Senators DINGELL and MC COTTER and referred to the Committee on Government Operations.

A bill to amend 1927 PA 175, entitled  
"The code of criminal procedure,"  
by amending section 16i of chapter XVII (MCL 777.16i), as amended  
by 2000 PA 279.

### CHAPTER XVII

Sec. 16i. This chapter applies to the following felonies  
enumerated in chapter 750 of the Michigan Compiled Laws:
