## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 27. (1) A proposal for a tax authorized to be levied

- 3 unless the proposal is adopted by a resolution of the council and
- 4 certified by the council not later than 70 days before the elec-
