A bill to amend 1969 PA 317, entitled "Worker's disability compensation act of 1969," by amending section 853 (MCL 418.853), as amended by 1994 PA 271.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 853. Process and procedure under this act shall be as

- 1 OF THIS SECTION, AN AUTHORIZED SIGNATURE INCLUDES, BUT IS NOT
