- 2 SEC. 4B. (1) THE DEPARTMENT SHALL ESTABLISH A FUGITIVE

- 5 TION SHALL BE DISTRIBUTED UPON REQUEST BY THE DEPARTMENT. AN

- 2 APPOINTED UNDER SECTION 2 OF 1935 PA 59, MCL 28.2.
- 3 (C) "LAW ENFORCEMENT AGENCY" MEANS THE DEPARTMENT, A POLICE
- 4 AGENCY OF A CITY, VILLAGE, OR TOWNSHIP OF THIS STATE, OR A
- 5 SHERIFF'S DEPARTMENT OF A COUNTY OF THIS STATE.
- 6 (D) "REGIONAL FUGITIVE TRANSPORTATION AGENCY" MEANS A LAW
- 7 ENFORCEMENT AGENCY THAT SERVES A CITY WITH A POPULATION OF NOT
- 8 LESS THAN 750,000 AND THAT TRANSPORTS PEOPLE ARRESTED AS
- 9 DESCRIBED IN SECTION 4 OF THIS CHAPTER.
- 10 (E) "REGIONAL FUGITIVE TRANSPORTATION TEAM" MEANS 2 OR MORE
- 11 LAW ENFORCEMENT AGENCIES THAT SERVE A CONTIGUOUS AREA AND THAT
- 12 ENTERED INTO A WRITTEN COOPERATIVE AGREEMENT TO TRANSPORT PEOPLE
- 13 ARRESTED AS DESCRIBED IN SECTION 4 OF THIS CHAPTER.
