A bill to amend 1974 PA 258, entitled "Mental health code,"

by amending section 134 (MCL 330.1134), as amended by 1994 PA 137, and by adding section 129.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 129. THE DEPARTMENT SHALL ESTABLISH AND MAINTAIN A
- 2 REGISTRY OF ALL FACILITY EMPLOYEES OR FORMER FACILITY EMPLOYEES,
- 3 WHO HAVE BEEN FOUND TO HAVE MISAPPROPRIATED THE PROPERTY OF,
