<ol> <li>Arts and Cultural Grants. The Governor recommended a 50% reduction. Recommended total funding for Arts and Cultural Grants would be \$11,771,300. The Senate recommends restoring \$646,500. The House concurred with the Governor.</li> </ol>	(646,500)
<ol> <li>Grants to Detroit and Grand Rapids Public Libraries. The Governor recommended a 6.6% reduction to each of these grants (\$132,500). The Senate recommends eliminating these grants lines and transferring the Federal funding into a Federal Aid to Libraries line item. The House restored 60% of current year funding to these line items.</li> </ol>	1,784,600
3. <b>State Aid to Libraries.</b> The Governor recommended a 6.6% reduction to this line (\$850,000). The Senate recommends maintaining current year funding at \$12,660,000. The House restored \$462,600 of the Governor's recommended reduction funding this line at \$12,271,900.	(388,100)
4. Federal Aid to Libraries. The Senate recommends transferring Federal Reed Act funding from the Library of Michigan Operations line, and the grant lines to the Detroit and Grand Rapids Public Libraries into this new line totaling \$1,211,300. The House transferred \$600,000 of this funding into the Detroit and Grand Rapids Public Library lines.	(600,000)
<ol> <li>Historical Administration and Services. The Governor recommended a (\$667,400) reduction in this line. The Senate recommends increasing the Freedom Trail Commission by \$3,500 and adding \$25,000 funding for Michigan History Day. The House reduced this line by \$100 to create an item of difference.</li> </ol>	(100)
6. <b>Office of Film and Television Services.</b> The Governor recommended a (\$15,100) reduction. The Senate recommends reducing by (\$2,700). The House reduced by (\$2,800).	(100)
7. <b>Special Collections Transition Funding.</b> The Senate created a \$150,000 line for the Detroit and Grand Rapids libraries. The House did not include this line item.	(150,000)
8. <b>\$100 Item of Difference.</b> The House reduced all GF/GP lines, not otherwise adjusted, by \$100 to create items of difference.	(1,300)

## Changes from FY 2003-04 Senate-Passed:

- 1. Arts and Cultural Grants. The Governor recommended: 1) deleting the requirement that the Council respond to unsuccessful applicants; 2) deleting the report to the Legislature from local governments and community foundations; 3) deleting the legislative district report on awardees; 4) changing the application fee from \$100.00 or 1% to \$300.00 or 3%. The Senate maintains the legislative district report but requires it be submitted electronically, added a new grant category titled Historical Projects Program, changed the percentage for the anchor program from 65 to 70, and added language restricting awards to 10% of the total appropriation for all grant recipients. The House struck the language restricting awards to 10% of the total appropriation for all grant recipients. (Sec. 401)
- Excess Proceeds from Collections in the State Historical Museum. The Governor recommended adding language
  allowing the Department to receive and expend excess proceeds from auctions, sales, or transfers of artifacts from the
  museum collections for additional materials for the collections. The Senate concurs and adds language requiring
  notification to the chairs of any sales or auctions. The House concurred and added the notification requirement to include
  the Vice Chair and Minority Vice Chair. (Sec. 505)
- 3. **Michigan History Magazine Subscriber List.** The Senate adds new language requiring the Department to make this list available to the Historical Society of Michigan. (Sec. 507)
- 4. **Report on the Detroit and Grand Rapids Public Libraries.** The Senate recommends deleting this section. The House reinstated this section. (Sec. 608)
- 5. **Federal Reed Act Work Project Account.** The Senate recommends adding new language redirecting the funding in the FY 2002 Work Project Account from the Detroit and Grand Rapids Public Libraries to a competitive grant award program for all eligible libraries. The House deletes language requiring this funding be distributed on a competitive basis and adds language requiring the funding to target libraries in high unemployment areas and provide the libraries with high speed internet connections and methods for sustainability. (Sec. 605)
- 6. **Special Collections.** The Senate recommends new language to split this funding \$100,000 for Detroit and \$50,000 for Grand Rapids and to require the Department to do a statewide study on the special collections. The House struck the language regarding the allocations to the two libraries but maintains the language regarding the study. (Sec. 606)
- 7. **Detroit Public Library.** The Senate added new language requiring the special collections be open on nights and weekends; requiring a report on patrons to the collection; and a plan for maintaining them when supplemental funding is eliminated. The House did not include the language regarding the plan for maintaining or dispersing the collections after supplemental funding ends or the language requiring these collections be open on nights and weekends.
