## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 803e. (1) A person who has been a prisoner of war or a
- 2 person whose spouse has been a prisoner of war may make

- 4 plate which shall be inscribed with special identification
- 5 numbers preceded by the letters "EX-POW" and shall have the words

- 3 (3) A person who was a member of the armed services during

- 26 the proof provided in subsection (5).
