SUBSTITUTE FOR

SENATE BILL NO. 1349

A bill to amend 1855 PA 105, entitled

"An act to regulate the disposition of the surplus funds in the state treasury; to provide for the deposit of surplus funds in certain financial institutions; to lend surplus funds pursuant to loan agreements secured by certain commercial, agricultural, or industrial real and personal property; to authorize the loan of surplus funds to certain municipalities; to authorize the participation in certain loan programs; to authorize an appropriation; and to prescribe the duties of certain state agencies,"

by amending section 2e (MCL 21.142e), as added by 2001 PA 123.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 2e. (1) The state treasurer may loan not more than
- 2 \$5,000,000.00 in surplus funds, without interest, to sugar beet
- 3 growers' cooperatives for the purpose of purchasing the assets of
- 4 1 or more agricultural processors if all of the following
- 5 conditions are met:
- 6 (a) The agricultural processor employs at least 300 full-time
- 7 employees and 1,000 seasonal employees and is in bankruptcy

- as amended September 22, 2004 proceedings or was in bankruptcy proceedings at any time during
- the 1-year period preceding the date of the loan.
- 3 (b) The loan amount does not exceed 10% of the total purchase
- price of the agricultural processor's assets.
- 5 (c) The loan is for a period not to exceed 5 years.
- (2) In addition to the conditions provided in subsection (1),
- the state treasurer may prescribe additional terms of a loan
- issued under this section.
- 9 (3) A sugar beet growers' cooperative that wishes to apply
- 10 for a loan under this section shall submit a loan application to
