SUBSTITUTE FOR SENATE BILL NO. 1317

A bill to create the Ronald Wilson Reagan memorial monument fund commission to govern the Ronald Wilson Reagan memorial monument fund; to prescribe the powers and duties of the commission and certain state departments and officers; to provide for penalties; and to provide for dissolution of the commission.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 1. This act shall be known and may be cited as the
- 2 "Ronald Wilson Reagan memorial monument fund commission act".
- 3 Sec. 2. As used in this act:
- 4 (a) "Commission" means the Ronald Wilson Reagan memorial
- 5 monument fund commission created in section 3.
- 6 (b) "Monument fund" means the Ronald Wilson Reagan memorial
- 7 monument fund created in the Ronald Wilson Reagan memorial
- 8 monument fund act.
- 9 Sec. 3. (1) The Ronald Wilson Reagan memorial monument fund

- 1 commission is created in the department of management and
- 2 budget. The commission is the governing body of the monument
- 3 fund. The commission shall consist of all of the following:
- 4 (a) The state treasurer or his or her designee.
- 5 (b) The attorney general or his or her designee.
- 6 (c) The secretary of state or his or her designee.
- 7 (d) Seven members appointed by the governor as follows:
- 8 (i) Two members selected by the governor.
- 9 (ii) Two members recommended by the senate majority leader.
- 10 (iii) Two members recommended by the speaker of the house of
- 11 representatives.
- 12 (iv) One member recommended by the Ronald Reagan presidential
- 13 foundation.
- 14 (2) Members of the commission shall serve for terms of 4
- 15 years or until a successor is appointed, whichever is later. If
- 16 a vacancy occurs on the commission, the vacancy shall be filled
- 17 in the same manner as the original appointment.
- 18 (3) The commission shall initially convene within 6 months
- 19 after the first deposit of money in the monument fund. The
- 20 commission shall meet often enough to expedite the completion of
- 21 the monument as prescribed in section 4. A majority of the
- 22 members of the commission constitute a quorum for conducting
- 23 business.
- 24 (4) The commission shall conduct its business at public
- 25 meetings held in compliance with the open meetings act, 1976 PA
- 26 267, MCL 15.261 to 15.275. A writing prepared, owned, used, in
- 27 the possession of, or retained by the commission in the

- 1 performance of an official function shall be available to the
- 2 public in compliance with the freedom of information act, 1976 PA
- **3** 442, MCL 15.231 to 15.246.
- 4 Sec. 4. The commission shall oversee the financing, design,
- 5 site location, and construction of a memorial monument dedicated
- 6 to President Ronald Wilson Reagan. The commission shall solicit
- 7 designs for the monument and shall select the final design.
- 8 Sec. 5. (1) The commission may accept on behalf of the
- 9 monument fund grants or gifts from the federal government, an
- 10 individual, a public or private corporation, organization, or
- 11 foundation, or any other source. The acceptance and use of
- 12 federal funds by the commission does not commit state money and
- 13 does not obligate the legislature to continue the purposes for
- 14 which federal money is made available. The commission shall
- 15 transmit money received under this section to the state treasurer
- 16 for deposit in the monument fund.
- 17 (2) A person shall not solicit or collect money for the
- 18 monument fund through the use of telemarketing.
- 19 (3) A person shall not conduct any fund-raising activities in
- 20 the name of the Ronald Wilson Reagan memorial monument fund
- 21 without prior written approval from the Ronald Wilson Reagan
- 22 memorial monument fund commission.
- 23 (4) A person shall not use the name or logo of the Ronald
- 24 Wilson Reagan memorial monument fund or commission in any
- 25 fund-raising activity without prior written approval of the
- 26 commission.
- 27 (5) A person who violates subsection (2), (3), or (4) is

- 1 guilty of a misdemeanor for each separate violation, punishable
- 2 by imprisonment for not more than 1 year or a fine of not more
- 3 than \$1,000.00, or both.
- 4 Sec. 6. After the completion of construction of the
- monument pursuant to section 4 and payment of all amounts due in
- connection with the monument, the commission is dissolved.
- 7 Enacting section 1. This act does not take effect unless
- 8 House Bill No. 6033 of the 92nd Legislature is enacted into law.
