A bill to amend the Initiated Law of 1996, entitled "Michigan gaming control and revenue act,"

by amending section 9b (MCL 432.209b), as added by 1997 PA 69.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 9b. (1) —A Except as provided in this section, a
- 2 person who holds a casino license shall not televise display or
- 3 allow any other person to -televise simulcast horse races on the
- 4 premises of the casino display a televised horse race at the
- 5 licensee's casino or as part of the licensee's casino operation.
- 6 (2) As used in this section, "simulcast" means the live
 - transmission of video and audio signals conveying a horse race
- 8 held either in or outside of this state. After obtaining
- 9 approval from the board, a casino licensee may apply for and hold
- 10 a license to operate a racing theater under the horse racing law
- 11 of 1995, 1995 PA 279, MCL 431.301 to 431.336. A racing theater

- 1 operated by a casino licensee is under the primary control of the
- 2 racing commissioner. However, the racing theater is part of the
- 3 licensee's casino operation under this act and subject to the
- 4 same control by the board as are other parts of the licensee's
- 5 casino operation. The board may take disciplinary action under
- 6 section 4a against a casino licensee that holds a racing theater
- 7 license for violation of the horse racing law of 1995, 1995 PA
- 8 279, MCL 431.301 to 431.336, or rules promulgated under that
- 9 act.
- 10 (3) A casino licensee is entitled to the same commission from
- 11 money wagered on horse races at the licensee's racing theater as
- 12 a race meeting licensee is entitled to receive from wagering on
- 13 horse races at a racing theater under article 3 of the horse
- 14 racing law of 1995, 1995 PA 279. The same taxes, fees, and other
- 15 deductions shall be subtracted and paid from the licensee's
- 16 commission as are subtracted and paid from a racing theater
- 17 licensee's commission under article 3 of the horse racing law of
- 18 1995, 1995 PA 279.
