THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 217j. (1) The choose life fund is created within the 2 state treasury.
- 3 (2) The state treasurer may receive money or other assets 4 from any source for deposit into the fund. The state treasurer 5 shall direct the investment of the fund. The state treasurer
- shall credit to the fund interest and earnings from fund
- investments.

- (3) Money in the fund at the close of the fiscal year shall remain in the fund and shall not lapse to the general fund.
- (4) The state treasurer shall disburse money in the fund on a semiannual basis to each county in proportion to the amount of

- 3 (5) As used in this section, "fund" means the choose life
