THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- Sec. 269. (1) For tax years that begin after December 31, 2002, a taxpayer may claim a credit against the tax imposed by 3 this act equal to 100% of the unreimbursed costs paid in the tax 4 year to provide qualified care for an eligible family member, not to exceed \$500.00.
 - (2) If the amount of the credit allowed under this section exceeds the tax liability of the taxpayer for the tax year, that portion of the credit that exceeds the tax liability shall not be refunded.
 - (3) As used in this section:
- (a) "Eligible family member" means a spouse, child, parent,

- 1 or grandparent of the taxpayer, or of the spouse of the taxpayer
