September 23, 2003, Introduced by Rep. Jamnick and referred to the Committee on Criminal Justice.

A bill to amend 1927 PA 175, entitled
"The code of criminal procedure,"
by amending section 16z of chapter XVII (MCL 777.16z), as amended
by 2002 PA 271.
