HOUSE BILL No. 5212

October 30, 2003, Introduced by Reps. Stewart, Hart and Pumford and referred to the Committee on Higher Education.

A bill to amend 1999 PA 94, entitled

"Michigan merit award scholarship act,"

by amending section 7 (MCL 390.1457), as amended by 2002 PA 736.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 7. (1) The Michigan merit award scholarship program is
- 2 established. The board shall administer the Michigan merit award
- 3 scholarship program.
- 4 (2) Subject to subsection (6), each student enrolled in grade
- 5 11 in or after the 1998-1999 school year who meets the
- 6 requirements of subsection (4), and subject to adjustment under
- 7 subsection (5), is eligible for the award of a \$2,500.00 Michigan
- 8 merit award scholarship if the student is enrolled in an approved
- 9 postsecondary educational institution in this state or in a
- 10 service academy, or the award of a \$1,000.00 Michigan merit award
- 11 scholarship if the student is enrolled in an approved

- 1 postsecondary educational institution outside this state other
- 2 than a service academy, if the board finds that the student while
- 3 in high school has taken the assessment test in the subject areas
- 4 of reading, writing, mathematics, and science, or beginning with
- 5 assessment tests taken by students after the 2003-2004 school
- 6 year, reading, writing, mathematics, science, and social studies,
- 7 and meets 1 of the following:
- 8 (a) Has received qualifying results in each of the subject
- 9 areas of reading, writing, mathematics, and science, or beginning
- 10 with assessment tests taken by students after the 2003-2004
- 11 school year, reading, writing, mathematics, science, and social
- 12 studies.
- 13 (b) Did not receive qualifying results in 1 or 2 of the
- 14 subject areas of reading, writing, mathematics, and science, or
- 15 beginning with assessment tests taken by students after the
- 16 2003-2004 school year, reading, writing, mathematics, science,
- 17 and social studies, but received an overall score in the top 25%
- 18 of a nationally recognized college admission examination.
- 19 (c) Did not receive qualifying results in 1 or 2 of the
- 20 subject areas of reading, writing, mathematics, and science, or
- 21 beginning with assessment tests taken by students after the
- 22 2003-2004 school year, reading, writing, mathematics, science,
- 23 and social studies, but received a qualifying score or scores as
- 24 determined by the board on a nationally recognized job skills
- 25 assessment test designated by the board.
- 26 (3) Subject to subsection (6) and to adjustment under
- 27 subsection (5), a student who was enrolled in grade 7 in or after

- 1 the 1999-2000 school year and who the board finds has taken the
- 2 assessment test in each of the subject areas while in grades 7
- 3 and 8 is eligible for 1 of the following additional Michigan
- 4 merit award scholarships:
- 5 (a) If the board finds that the student while in grades 7 and
- 6 8 received qualifying results in 2 of the subject areas of
- 7 reading, writing, mathematics, and science, an additional
- 8 Michigan merit award scholarship of \$250.00.
- 9 (b) If the board finds that the student while in grades 7 and
- 10 8 received qualifying results in 3 of the subject areas of
- 11 reading, writing, mathematics, and science, an additional
- 12 Michigan merit award scholarship of \$375.00.
- 13 (c) If the board finds that the student while in grades 7 and
- 14 8 received qualifying results in all of the subject areas of
- 15 reading, writing, mathematics, and science, an additional
- 16 Michigan merit award scholarship of \$500.00.
- 17 (4) In addition to the requirements set forth in subsections
- 18 (2) and (3), to be eligible for the award of 1 or both Michigan
- 19 merit award scholarships under this section, the board must find
- 20 that a student satisfies all of the following:
- 21 (a) The student has graduated from high school or passed the
- 22 general educational development (GED) test or other graduate
- 23 equivalency examination approved by the state board.
- 24 (b) The student graduated from high school or passed the
- 25 general educational development (GED) test or other graduate
- 26 equivalency examination approved by the state board within 1 of
- 27 the following time periods:

- 1 (i) If the student graduated from high school or passed the
- 2 test or examination before March 1, 2002, within the 7-year
- 3 period preceding the student's application to receive his or her
- 4 Michigan merit award scholarship money.
- 5 (ii) If the student graduated on or after March 1, 2002,
- 6 within the 4-year period preceding the date of the student's
- 7 application to receive his or her Michigan merit award
- 8 scholarship money, or if the student becomes a member of the
- 9 United States armed forces or peace corps during this 4-year
- 10 period and serves for 4 years or less, the 4-year period is
- 11 extended by a period equal to the number of days the student
- 12 served as a member of the United States armed forces or peace
- 13 corps. The board may also extend the 4-year period if the board
- 14 determines that an extension is warranted because of an illness
- 15 or disability of the student or in the student's immediate family
- 16 or another family emergency.
- 17 (c) The student is enrolled in an approved postsecondary
- 18 educational institution. For students who qualify under
- 19 subsection (2)(c), the student is enrolled in a vocational or
- 20 technical education program at an approved postsecondary
- 21 educational institution.
- 22 (d) The student has not been convicted of a felony involving
- 23 an assault, physical injury, or death.
- (e) The student satisfies any additional eligibility
- 25 requirements established by the board.
- (5) In any fiscal year, the board may adjust the amount of a
- 27 Michigan merit award scholarship available to students eligible

- 1 under 1 or more of subsections (2), (3), and (9), based upon its
- 2 determination of available resources and amounts appropriated,
- 3 but the board shall not increase an amount by more than 5% in any
- 4 fiscal year. The board shall notify the governor, the speaker of
- 5 the house of representatives, and the majority leader of the
- 6 senate in writing at least 30 days before an adjustment under
- 7 this subsection.
- **8** (6) For assessment tests administered after January 1, 2000,
- 9 the board shall not use the assessment test to determine
- 10 eligibility for a Michigan merit award scholarship under this
- 11 section for a particular year unless the board has reviewed and
- 12 approved the assessment test before it was administered for that
- **13** year.
- 14 (7) The board shall provide each student written notice of
- 15 whether or not the student is eligible for the award of 1 or more
- 16 Michigan merit award scholarships described in this section. If
- 17 the student is eligible, the written notice shall also contain
- 18 the Michigan merit award scholarship amount for which the student
- 19 is eligible, how the student applies for payment of Michigan
- 20 merit award scholarship, and any other information the board
- 21 considers necessary regarding qualification requirements or
- 22 conditions relating to the use of the Michigan merit award
- 23 scholarship.
- (8) It is the intent of the legislature that the level of
- 25 student performance required to achieve qualifying results in a
- 26 subject area of an assessment test remains approximately the
- 27 same, and that the board not reduce the required level of student

- 1 performance as a means of increasing the number of Michigan merit
- 2 award scholarships awarded.
- 3 (9) If a student who has previously received a \$1,000.00
- 4 Michigan merit award scholarship as a student enrolled in an
- 5 approved postsecondary educational institution outside of this
- 6 state other than a service academy enrolls in an approved
- 7 postsecondary educational institution in this state and meets the
- 8 requirements of subsection (4), and subject to adjustment under
- 9 subsection (5), the student is eligible for the award of an
- 10 additional \$1,500.00 Michigan merit award scholarship.
- 11 (10) A pupil who does not initially receive qualifying
- 12 results shall be extended an opportunity to achieve the requisite
- 13 qualifying results by taking a subsequent assessment test.
- 14 (11) A nonpublic school student or home school student may
- 15 take, and the board shall administer if requested, an assessment
- 16 test at a site designated by the board.
- 17 (12) As used in this section, "social studies" means that
- 18 term as defined in section 1279 of the revised school code, 1976
- 19 PA 451, MCL 380.1279.
