Sec. 1744. (1) Each intermediate school board shall appoint
a special education parent advisory committee. The parent
advisory committee and its officers shall consist only of parents
of pupils with disabilities, with at least 1 parent from each
constituent district and public school academy unless no parent
agrees to serve on the parent advisory committee to represent the
constituent district or public school academy. Each constituent
district board and each public school academy board of directors
shall nominate at least 1 parent to serve on the parent advisory

The intermediate school board may appoint additional

members not to exceed 1/3 of the total parent advisory committee
