April 1, 2004, Introduced by Rep. Koetje and referred to the Committee on Commerce.

A bill to amend 1927 PA 175, entitled  
"The code of criminal procedure,"  
by amending section 14j of chapter XVII (MCL 777.14j), as added  
by 2002 PA 29.
