## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 4116. (1) Beginning the effective date of the
- 2 amendatory act that added this subsection and notwithstanding any
- 3 other provision of this act, the department shall issue an
- 4 initial or renewal license within the time period prescribed by
- 5 this act but not later than 6 months after the applicant files a
- 6 completed application. If the application is considered
- 7 incomplete by the department, the department shall notify the
  - B applicant in writing within 10 days after receipt of the
- 9 incomplete application, describing the deficiency and requesting
- 10 the additional information. The 6-month period is tolled upon
- 11 notification by the department of a deficiency until the date the

- 2 (2) If the department fails to issue or deny a license within
- 3 the time required by this section, the department shall return
- 4 the license fee and shall reduce the license fee for the

- 7 processing of the application based upon the fact that the
- 8 application fee was refunded or discounted under this

- 10 (3) Beginning January 31, 2005, the director of the
