SENATE BILL No. 30

January 21, 2003, Introduced by Senator SWITALSKI and referred to the Committee on Commerce and Labor.

A bill to amend 1986 PA 87, entitled

"An act regarding warranties on new motor vehicles; to require certain repairs to new motor vehicles; to provide remedies for the failure to repair such vehicles; and to prescribe duties for certain state agencies,"

by amending section 1 (MCL 257.1401), as amended by 1998 PA 486.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 1. As used in this act:
- 2 (a) "Consumer" means 1 or more of the following:
- 3 (i) A person who purchases or leases a new motor vehicle for
- 4 personal, family, or household use and not for the purpose of
- 5 selling or leasing the new motor vehicle to another person.
- $\mathbf{6}$ (ii) A person who purchases or leases less than 10 new motor
 - ' vehicles a year.
 - (iii) A person who purchases or leases 10 or more new motor
- 9 vehicles a year only if the vehicles are purchased or leased for
- 10 personal, family, or household use.

- 3 (b) "Lessee" means a person who, under a lease, acquires the
- 4 right to possession and use of a new motor vehicle.
- 5 (c) "Lessor" means a person who, under a lease, transfers the
- 6 right to possession and use of a new motor vehicle.
- 7 (d) "Manufacturer" means a person who manufactures,
- 8 assembles, or is a distributor of new motor vehicles and includes
- 9 an agent of a manufacturer but does not include a new motor
- 10 vehicle dealer.
- 11 (e) "Manufacturer's express warranty" means an express
- 12 warranty as determined under the uniform commercial code, 1962

- (f) "Motor vehicle" means a motor vehicle as defined in
- 16 section 33 of the Michigan vehicle code, 1949 PA 300, MCL 257.33,
- 17 that is designed as a passenger vehicle, motor home, or sport
- 18 utility vehicle, but does not include a -motor home, bus, truck
- 19 other than a pickup truck or van, or a vehicle designed to travel
- 20 on less than 4 wheels.
- 21 (g) "Motor home" means a motor home as defined in section 32a
- 22 of the Michigan vehicle code, 1949 PA 300, MCL 257.32a.
- 23 (h) -(g) "New motor vehicle" means a motor vehicle that is
- 24 purchased or leased in this state or purchased or leased by a
- 25 resident of this state and is covered by a manufacturer's express
- 26 warranty at the time of purchase or lease.
- (i) -(h) "New motor vehicle dealer" means a person or that

- 26 (l) $\frac{(k)}{(k)}$ "Lease price" means the actual vehicle sales price
- 27 paid by the lessor including any cash payment by the consumer and

- 1 the sum equal to any allowance for any trade-in but excludes debt
- 2 from any other transaction as well as any manufacturer to
- 3 consumer discount, rebate, or incentive appearing in the
- 4 agreement or contract that the consumer received or that was
- 5 applied to reduce the purchase or lease cost. Additionally, any
- 6 sales tax, license and registration fees, and similar government
- 7 charges not included elsewhere paid by the lessor on behalf of
- 8 the lessee are included as a part of lease price.
- 9 (m) $\frac{-(l)}{}$ "Purchase price" means the actual vehicle sales
- 10 price listed on the buyer's order including any cash payment by
- 11 the consumer and the sum equal to any allowance for any trade-in
- 12 but excludes debt from any other transaction as well as any
- 13 manufacturer to consumer discount, rebate, or incentive appearing
- 14 in the agreement or contract that the consumer received or that
- 15 was applied to reduce the purchase cost. Additionally, any sales
- 16 tax, license and registration fees, and similar government
- 17 charges not included elsewhere paid by the consumer are included
- 18 as a part of purchase price.
