

# SENATE BILL No. 508

May 21, 2003, Introduced by Senators SANBORN, TOY, GILBERT and GARCIA and referred to the Committee on Judiciary.

A bill to amend 1927 PA 175, entitled "The code of criminal procedure," by amending section 16i of chapter XVII (MCL 777.16i), as amended by 2002 PA 278.

**THE PEOPLE OF THE STATE OF MICHIGAN ENACT:**

CHAPTER XVII

Sec. 16i. This chapter applies to the following felonies enumerated in chapter 750 of the Michigan Compiled Laws:
