CHAPTER XI

- 5 750.411i, and section 3 of this chapter. The probation is subject
- 6 to revocation for any violation of a condition of that probation.
- 7 (3) THE COURT MAY PLACE AN INDIVIDUAL CONVICTED OF A VIOLATION
- 8 OF SECTION 136B OF THE MICHIGAN PENAL CODE, 1931 PA 328, MCL
- 9 750.136B, THAT IS DESIGNATED AS A MISDEMEANOR ON PROBATION FOR NOT
- 10 MORE THAN 5 YEARS.
- 11 (4) $\overline{(3)}$ The court shall by order, to be filed or entered in
- 12 the cause as the court directs by general rule or in each case, fix
- 13 and determine the period and conditions of probation. The order is
- 14 part of the record in the cause. The court may amend the order in
- 15 form or substance at any time.
- 16 (5) -(4) Subsections (1), (2), -and (3), AND (4) do not
- 17 apply to a juvenile placed on probation and committed under section
- 18 1(3) or (4) of chapter IX to an institution or agency described in
- 19 the youth rehabilitation services act, 1974 PA 150, MCL 803.301 to
- 20 803.309.
- 21 (6) -(5) Except as otherwise provided by law, the court may
- 22 place an individual convicted of a listed offense on probation
- 23 subject to the requirements of this subsection and subsections -(6)
- 24 (7) through -(11) (12) for any term of years but not less than 5
- 25 years.
- 26 (7) -(6) Except as otherwise provided in subsections -(7)
- 27 (8) to -(11) (12), if an individual is placed on probation under

- 3 (a) Reside within a student safety zone.
- **4** (b) Work within a student safety zone.
- 5 (c) Loiter within a student safety zone.
- 6 (8) -(7) The court shall not impose a condition of probation
- 7 described in subsection $\frac{-(6)(a)}{}$ (7)(A) if any of the following
- 8 apply:
- 9 (a) The individual is not more than 19 years of age and
- 10 attends secondary school or postsecondary school, and resides with
- 11 his or her parent or guardian. However, an individual described in
- 12 this subdivision shall be ordered not to initiate or maintain
- 13 contact with a minor within that student safety zone. The
- 14 individual shall be permitted to initiate or maintain contact with
- 15 a minor with whom he or she attends secondary school or
- 16 postsecondary school in conjunction with that school attendance.
- 17 (b) The individual is not more than 26 years of age, attends a
- 18 special education program, and resides with his or her parent or
- 19 guardian or in a group home or assisted living facility. However,
- 20 an individual described in this subdivision shall be ordered not to
- 21 initiate or maintain contact with a minor within that student
- 22 safety zone. The individual shall be permitted to initiate or
- 23 maintain contact with a minor with whom he or she attends a special
- 24 education program in conjunction with that attendance.
- 25 (c) The individual was residing within that student safety
- 26 zone at the time the amendatory act that added this subdivision was
- 27 enacted into law. However, if the individual was residing within

- 2 this subdivision was enacted into law, the court shall order the
- 3 individual not to initiate or maintain contact with any minors

- 12 maintains contact with a minor within that student safety zone.
- 13 (10) $\frac{(9)}{}$ The court shall not impose a condition of probation
- 14 described in subsection $\frac{(6)(b)}{(7)(B)}$ if the individual was
- 15 working within the student safety zone at the time the amendatory
- 16 act that added this subsection was enacted into law. However, if
- 17 the individual was working within the student safety zone at the
- 18 time the amendatory act that added this subsection was enacted into
- 19 law, the court shall order the individual not to initiate or
- 20 maintain contact with any minors in the course of his or her
- 21 employment within that student safety zone. This subsection does
- 22 not prohibit the court from allowing contact with any minors named
- 23 in the probation order for good cause shown and as specified in the
- 24 probation order.
- 25 (11) -(10) The court shall not impose a condition of
- 26 probation described in subsection $\frac{(6)(b)}{(7)(B)}$ if the individual
- 27 only intermittently or sporadically enters a student safety zone

- 1 for purposes of work. If the individual intermittently or
- 2 sporadically works within a student safety zone, the court shall
- 3 order the individual not to initiate or maintain contact with any
- 4 minors in the course of his or her employment within that safety
- 5 zone. This subsection does not prohibit the court from allowing
- 6 contact with any minors named in the probation order for good cause
- 7 shown and as specified in the probation order.
- 8 (12) $\frac{11}{11}$ The court may exempt an individual from probation
- 9 under subsection $\frac{(5)}{(6)}$ if any of the following apply:
- 10 (a) The individual has successfully completed his or her
- 11 probationary period under sections 11 to 15 of chapter II for
- 12 committing a listed offense and has been discharged from youthful
- 13 trainee status.
- 14 (b) The individual was convicted of committing or attempting
- 15 to commit a violation solely described in section 520e(1)(a) of the
- 16 Michigan penal code, 1931 PA 328, MCL 750.520e, and at the time of
- 17 the violation was 17 years of age or older but less than 21 years
- 18 of age and is not more than 5 years older than the victim.
- 19 (13) -(12) As used in this section:
- 20 (a) "Listed offense" means that term as defined in section 2
- 21 of the sex offenders registration act, 1994 PA 295, MCL 28.722.
- 22 (b) "Loiter" means to remain for a period of time and under
- 23 circumstances that a reasonable person would determine is for the
- 24 primary purpose of observing or contacting minors.
- 25 (c) "Minor" means an individual less than 18 years of age.
- 26 (d) "School" means a public, private, denominational, or
- 27 parochial school offering developmental kindergarten, kindergarten,

- 1 or any grade from 1 through 12. School does not include a home
- 2 school.
- 3 (e) "School property" means a building, facility, structure,
- 4 or real property owned, leased, or otherwise controlled by a
- 5 school, other than a building, facility, structure, or real
- 6 property that is no longer in use on a permanent or continuous
- 7 basis, to which either of the following applies:
- 8 (i) It is used to impart educational instruction.
- 9 (ii) It is for use by students not more than 19 years of age
- 10 for sports or other recreational activities.
- 11 (f) "Student safety zone" means the area that lies 1,000 feet
- 12 or less from school property.
