January 27, 2005, Introduced by Reps. Caul, Brown and Ball and referred to the Committee on Veterans Affairs and Homeland Security.

A bill to establish an undergraduate tuition waiver program for children of certain deceased or disabled members of the armed forces of the United States; to provide for the administration of the tuition waiver program; to prescribe certain powers and duties of certain state officers, agencies, and departments; and to repeal acts and parts of acts.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- Sec. 1. This act shall be known and may be cited as the
 "children of veterans tuition act".
 - Sec. 2. As used in this act:
 - (a) "Academic year" means the period from August 1 of a calendar year to July 31 of the next calendar year.
 - (b) "Authority" means the Michigan higher education assistance

- 1 authority created by 1960 PA 77, MCL 390.951 to 390.961.
- 2 (c) "Eligible institution" means a degree or certificate
- 3 granting public or independent nonprofit college or university,
- 4 junior college, or community college in this state.
- 5 (d) "Eligible tuition" means the tuition charged by an
- 6 eligible institution for an undergraduate class.
- 7 (e) Full-time" means enrolled in at least 12 credit hours in
- 8 an academic semester or its equivalent number of credit hours in a
- 9 term or quarter, as determined by the authority.
- 10 (f) "Michigan veteran" means an individual whose legal
- 11 residence immediately before entering military service was in this
- 12 state and who does not later reside outside of this state for a

- 15 (g) "Undergraduate class" means a class or course that

- 18 Sec. 3. The children of veterans tuition waiver program is
- 19 created, to be administered by the authority. The authority shall
- 20 do all of the following:
- 21 (a) Provide tuition waivers at eligible institutions for
- 22 eligible students under this act.
- 23 (b) Develop a tuition waiver agreement to be entered into by a
- 24 tuition waiver recipient and the eligible institution that contains
- 25 the terms of a tuition waiver made under this act and the rights
- 26 and obligations of the recipient and the eliqible institution.
- (c) Within 120 days after the effective date of this act,

- 1 notify recipients of benefits under 1935 PA 245, MCL 35.111 to
- 2 35.112, of the repeal of that act and the availability of tuition
- 3 waivers under this act.
- 4 (d) Promulgate rules to implement and administer this act
- 5 under the administrative procedures act of 1969, 1969 PA 306, MCL
- 6 24.201 to 24.328. The rules may include additional standards of
- 7 eligibility for students to receive tuition waivers under this act.
- 8 Sec. 4. (1) Beginning in the 2005-2006 academic year, an
- 9 eligible institution that agrees to participate in the tuition
- 10 waiver program established by this act shall waive tuition in an
- 11 amount determined under subsection (2) for any student who meets
- 12 all of the following requirements:
- 13 (a) Is enrolled in that academic year as a full-time student
- 14 in undergraduate classes at an eligible institution.
- 15 (b) Is a United States citizen or permanent resident of the
- 16 United States.
- 17 (c) Is more than 16 and less than 26 years of age.
- 18 (d) Is the natural or adopted child of a Michigan veteran and
- 19 the Michigan veteran meets or met any of the following:
- (i) He or she was killed in action or died from another cause
- 21 while serving in a war or war condition in which the United States
- 22 was or is a participant.
- 23 (ii) The United States department of veterans affairs has
- 24 determined that he or she died or is totally and permanently
- 25 disabled as a result of a service-connected illness or injury.
- 26 (iii) The United States department of veterans affairs has
- 27 determined he or she was permanently and totally disabled as a

- 1 result of a service-connected illness or injury before death, and
- 2 he or she died from any cause.
- 3 (iv) He or she is officially listed by the United States
- 4 government as missing in action in a foreign country.
- 5 (e) Has resided continuously in this state for the 12 months
- 6 immediately preceding the date of his or her application and is not
- 7 a resident of any other state.
- 8 (f) Has maintained a cumulative grade point average of at
- 9 least 2.25 in any undergraduate classes he or she completed at any
- 10 eligible institution in any previous academic years.
- 11 (q) Has signed a written tuition waiver agreement with the
- 12 eligible institution.
- 13 (h) Is in compliance with this act and the rules promulgated
- 14 under this act.
- (i) Has not been convicted of a felony involving an assault,
- 16 physical injury, or death.
- 17 (j) Meets any other standards established in rules promulgated
- 18 by the authority under section 3.
- 19 (2) Except as provided in subsection (3), the amount of a
- 20 tuition waiver described in subsection (1) in an academic year is
- 21 \$2,800.00, or an amount equal to all of the student's eligible
- 22 tuition in that academic year, whichever is less.
- 23 (3) If a student is receiving tuition waiver assistance in the
- 24 2004-2005 academic year under the tuition waiver program provided
- 25 in 1935 PA 245, MCL 35.111 to 35.112, is a person described in
- 26 section 1(3) of 1935 PA 245, MCL 35.111, and meets the eligibility
- 27 requirements of this act, the amount of the tuition waiver for that

- 1 student in the 2005-2006 academic year is an amount equal to the
- 2 student's eligible tuition in that academic year.
- 3 (4) An individual shall not receive tuition waiver assistance
- 4 under this act, or under this act and the tuition waiver program
- **5** provided in 1935 PA 245, MCL 35.111 to 35.112, in more than 4
- 6 academic years.
- 7 Sec. 5. (1) Beginning in the 2005-2006 academic year, within
- 8 60 days after the end of an academic year an eligible institution
- 9 shall apply to the authority for reimbursement of tuition waived
- 10 under this act in that academic year. The application shall include
- 11 the total number of students whose tuition was waived; the total
- 12 amount of reimbursement requested by the eligible institution; and
- 13 an itemization of the waivers that includes the name of each
- 14 student receiving a tuition waiver, the amount of that waiver, the
- 15 student's grade point average for the academic year, the student's
- 16 cumulative grade point average, the student's transcript for the
- 17 academic year, and a certification that the student meets the
- 18 eligibility requirements for tuition reimbursement under this act
- 19 in the amount requested by the eligible institution.
- 20 (2) The authority shall verify the amount of reimbursement to
- 21 which an eligible institution is required and report that
- 22 information to the house and senate appropriation subcommittees on
- 23 higher education and community colleges.
- 24 (3) The legislature shall appropriate money for reimbursement
- 25 to the eligible institution if the institution receives annual
- 26 appropriations from this state or to the authority for distribution
- 27 to the eligible institution if the institution does not receive

- 1 annual appropriations from this state. Money appropriated under
- 2 this subsection shall be used only for tuition waivers under this
- 3 act.
- 4 Enacting section 1. 1935 PA 245, MCL 35.111 to 35.112, is
- 5 repealed effective July 31, 2005.
- 6 Enacting section 2. This act does not take effect unless
- 7 Senate Bill No. ____ or House Bill No. 4002(request no. 00021'05 a)
- 8 of the 93rd Legislature is enacted into law.
