SUBSTITUTE FOR HOUSE BILL NO. 4138

A bill to provide for standards of accessibility for certain publicly funded housing; and to provide for certain powers and duties of certain state authorities.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 1. This act shall be known and may be cited as the
- 2 "inclusive home design act".
- 3 Sec. 2. As used in this act:
- 4 (a) "Applicant" means 1 or more individuals, corporations,
- 5 nonprofit corporations, partnerships, associations, limited
- 6 liability companies, labor organizations, mutual corporations,
- 7 joint stock companies, trusts, unincorporated associations,
- 8 trustees, and entities formed under the state housing development
- 9 authority act of 1966, 1966 PA 346, MCL 125.1401 to 125.1499c.

- 1 (b) "Authority" means the Michigan state housing development
- 2 authority created in the state housing development authority act of
- 3 1966, 1966 PA 346, MCL 125.1401 to 125.1499c.
- 4 (c) "Family residential real estate" means real property
- 5 located in this state, to be newly constructed for residential
- 6 purposes and intended for occupancy by a single family, 2 families,
- 7 or 3 families and that is constructed using funds provided as a
- 8 construction period loan, a bridge loan, or other temporary
- 9 financing with a term of not more than 24 months and that are
- 10 provided under the state housing development authority act of 1966,
- 11 1966 PA 346, MCL 125.1401 to 125.1499c. Family residential real
- 12 estate does not include upper units in duplexes that are designed
- in an over-and-under fashion.
- Sec. 3. Beginning January 1, 2007, at least 50% of family
- 15 residential real estate that is to be newly constructed after
- 16 December 31, 2006 and that is receiving funding under the state
- 17 housing development authority act of 1966, 1966 PA 346, MCL
- 18 125.1401 to 125.1499c, shall be constructed so that the family
- 19 residential real estate complies with the accessibility provisions
- 20 of the Michigan building code adopted under the Stille-DeRossett-
- 21 Hale single state construction code act, 1972 PA 230, MCL 125.1501
- 22 to 125.1531, for type "B" dwelling or sleeping units as defined in
- 23 section 1102.1 of the Michigan building code.
- 24 Sec. 4. Each applicant for assistance from the authority shall
- 25 submit an assurance on forms developed and provided by the
- 26 authority that family residential real estate to be newly
- 27 constructed after December 31, 2006 with funding provided by the
