SUBSTITUTE FOR HOUSE BILL NO. 4289

A bill to amend 1995 PA 29, entitled "Uniform unclaimed property act,"

(MCL 567.221 to 567.265) by adding section 19a.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 19A. (1) BEGINNING OCTOBER 1, 2005, EACH YEAR THE
- 2 ADMINISTRATOR SHALL COMPARE THE LIST OF PERSONS APPEARING TO BE
- 3 OWNERS OF ABANDONED PROPERTY AGAINST RECORDS MAINTAINED BY THE
- 4 DEPARTMENT OF TREASURY THAT CONTAIN SOCIAL SECURITY NUMBERS OR TAX
- 5 IDENTIFICATION NUMBERS. IF THE ADMINISTRATOR DETERMINES THAT A
- 6 PERSON APPEARS TO BE THE OWNER OF ABANDONED PROPERTY BEING HELD BY
- 7 THIS STATE, THE ADMINISTRATOR SHALL ATTEMPT TO NOTIFY THAT PERSON
- 8 IN WRITING THAT THE PERSON MAY BE THE OWNER OF ABANDONED PROPERTY
- 9 HELD BY THIS STATE AND REQUEST THAT PERSON TO CONTACT THE
- 10 ADMINISTRATOR SO THAT THE ADMINISTRATOR MAY OBTAIN SUFFICIENT
- 11 INFORMATION TO DETERMINE WHETHER THE PERSON IS THE OWNER OF THE

- 1 ABANDONED PROPERTY.
- 2 (2) IF, BASED UPON THE PROCEDURE PROVIDED IN SUBSECTION (1),
- 3 THE ADMINISTRATOR HAS DETERMINED THAT A PERSON IS THE OWNER OF
- ABANDONED PROPERTY AND HAS DETERMINED THAT PERSON'S CURRENT ADDRESS
- AND IF THE PROPERTY IS MONEY, THE ADMINISTRATOR SHALL DIRECTLY PAY 5
- 6 THE PERSON WHO IS THE OWNER OF THE ABANDONED PROPERTY.
- 7 (3) FUNDS AVAILABLE UNDER SECTION 24 MAY BE APPROPRIATED FOR
- ACTIVITIES IDENTIFIED IN THIS SECTION. THE ADMINISTRATOR'S 8
- 9 OBLIGATION UNDER THIS SECTION IS LIMITED TO THE AMOUNT OF A
- 10 SEPARATE LINE-ITEM APPROPRIATION AND A SEPARATELY IDENTIFIED
- 11 INCREASE IN THE NUMBER OF FULL-TIME EQUIVALENT EMPLOYEES SUFFICIENT
- 12 RELATIVE TO THE NUMBER OF EMPLOYEES PERFORMING THE ADMINISTRATOR'S
- CURRENT DUTIES UNDER THIS ACT, IDENTIFIED FOR THE PURPOSE OF 13
- 14 FUNDING THE ADMINISTRATOR'S DUTIES UNDER THIS SECTION AND INCLUDED
- 15 IN THE ANNUAL APPROPRIATIONS ACT MAKING APPROPRIATIONS FOR THE
- DEPARTMENT OF TREASURY. 16
