

SUBSTITUTE FOR
HOUSE BILL NO. 4452
(As amended April 26, 2005)

A bill to amend 1987 PA 96, entitled
"The mobile home commission act,"
by amending section 30d (MCL 125.2330d).

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 Sec. 30d. (1) ~~If~~ **ALL OF THE FOLLOWING APPLY IF** an owner
2 named in a certificate of title creates a security interest in the
3 mobile home described in the certificate:
4 (a) The owner shall immediately execute an application in the
5 form prescribed by the department showing the name and address of
6 the holder of the security interest and deliver the certificate of
7 title, **THE** application, ~~and~~ ~~[a fee of \$1.00]~~ ~~together with~~ **AND** a
8 copy of the application which need not be signed, to the holder of

1 the security interest.

2 (b) The holder of the security interest shall cause the
3 certificate of title, **THE** application, ~~and~~ **THE REQUIRED** fee, and
4 the copy of the application to be mailed or delivered to the
5 department.

6 (c) The department shall indicate on the copy of the
7 application the date and place of filing of the application and
8 return the copy to the person presenting it.

9 (d) Upon receipt of the certificate of title, application, and
10 the required fee, the department shall issue a new certificate in
11 the form provided ~~by~~ **IN** section 30b, setting forth the name and
12 address of each holder of a security interest in the mobile home
13 for which a termination statement has not been filed and the date
14 on which the application first stating the security interest was
15 filed, and mail the certificate to the owner.

16 (2) A holder of a security interest may assign, absolutely or
17 otherwise, the security interest to a person other than the owner
18 without affecting the interest of the owner or the validity of the
19 security interest, but a person without notice of the assignment is
20 protected in dealing with the holder of the security interest as
21 the holder of the security interest. The assignee may have ~~the~~
22 ~~certificate of title indorsed with the assignee named~~ **ITS INTEREST**
23 as the holder of the security interest **SHOWN ON THE CERTIFICATE OF**
24 **TITLE** by providing the department with a copy of the assignment
25 instrument but the failure of the assignee to do so ~~shall~~ **DOES**
26 not affect the validity of the security interest or the assignment
27 of the security interest.

1 (3) The filing ~~under this section or under section 30a~~ of an
2 application for a certificate of title ~~showing the name and~~
3 ~~address of the holder of~~ **INDICATING** a security interest in a
4 mobile home **UNDER THIS ACT IS REQUIRED TO PERFECT THE SECURITY**
5 **INTEREST UNDER THIS ACT AND** is equivalent to the filing of a
6 financing statement with respect to the security interest under
7 article 9 of the uniform commercial code, ~~Act No. 174 of the~~
8 ~~Public Acts of 1962, being sections 440.9101 to 440.9994 of the~~
9 ~~Michigan Compiled Laws 1962 PA 174, MCL 440.9101 TO 440.9994. A~~
10 **SECURITY INTEREST IN A MOBILE HOME PERFECTED UNDER THIS ACT HAS**
11 **PRIORITY RIGHTS OVER THE RIGHTS OF A LIEN CREDITOR.**

12 (4) ~~When~~ **IF** there is not an outstanding obligation or
13 commitment to make advances, incur obligations, or otherwise give
14 value, secured or to be secured by a security interest in a mobile
15 home, the secured party shall, within ~~10~~ **30** days after
16 satisfaction of the obligation, ~~and, in any event within 30 days,~~
17 execute a termination statement in the form prescribed by the
18 department and mail or deliver the termination statement to the
19 owner or other person as the owner may direct. ~~The owner other~~
20 ~~than~~ **AN OWNER WHO IS NOT** a dealer holding the mobile home for
21 resale, shall promptly cause the certificate, all termination
22 statements, **[and]** an application for certificate of title,
23 ~~accompanied by [a fee of \$1.00]~~ to be mailed or delivered to the
24 department. ~~, which~~ **THE DEPARTMENT** shall issue a new certificate.
