SUBSTITUTE FOR HOUSE BILL NO. 4670

A bill to amend 1978 PA 368, entitled "Public health code,"

(MCL 333.1101 to 333.25211) by adding section 16184.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 16184. (1) AN INDIVIDUAL WHO IS RETIRED FROM THE ACTIVE
- 2 PRACTICE OF MEDICINE OR OSTEOPATHIC MEDICINE AND SURGERY AND WHO
- 3 WISHES TO DONATE HIS OR HER EXPERTISE FOR THE MEDICAL CARE AND
- 4 TREATMENT OF INDIGENT AND NEEDY INDIVIDUALS IN THIS STATE OR FOR
- 5 THE MEDICAL CARE AND TREATMENT OF INDIVIDUALS IN MEDICALLY
- 6 UNDERSERVED AREAS OF THIS STATE MAY OBTAIN A SPECIAL VOLUNTEER
- 7 LICENSE TO ENGAGE IN THE PRACTICE OF MEDICINE OR OSTEOPATHIC
- 8 MEDICINE AND SURGERY BY SUBMITTING AN APPLICATION TO THE BOARD
- 9 PURSUANT TO THIS SECTION. AN APPLICATION FOR A SPECIAL VOLUNTEER

- 1 LICENSE SHALL BE ON A FORM PROVIDED BY THE DEPARTMENT AND SHALL
- 2 INCLUDE EACH OF THE FOLLOWING:
- 3 (A) DOCUMENTATION THAT THE INDIVIDUAL HAS BEEN PREVIOUSLY
- 4 LICENSED TO ENGAGE IN THE PRACTICE OF MEDICINE OR OSTEOPATHIC
- 5 MEDICINE AND SURGERY IN THIS STATE AND THAT HIS OR HER LICENSE WAS
- 6 IN GOOD STANDING PRIOR TO THE EXPIRATION OF HIS OR HER LICENSE.
- 7 (B) ACKNOWLEDGMENT AND DOCUMENTATION THAT THE APPLICANT WILL
- 8 NOT RECEIVE ANY PAYMENT OR COMPENSATION, EITHER DIRECT OR INDIRECT,
- 9 OR HAVE THE EXPECTATION OF ANY PAYMENT OR COMPENSATION, FOR ANY
- 10 MEDICAL CARE SERVICES PROVIDED UNDER THE SPECIAL VOLUNTEER LICENSE.
- 11 (C) IF THE APPLICANT HAS BEEN OUT OF PRACTICE FOR 3 OR MORE
- 12 YEARS, DOCUMENTATION THAT, DURING THE 3 YEARS IMMEDIATELY PRECEDING
- 13 THE APPLICATION, HE OR SHE HAS ATTENDED AT LEAST 2/3 OF THE
- 14 CONTINUING EDUCATION COURSES OR PROGRAMS REQUIRED UNDER PART 170 OR
- 15 175 FOR THE RENEWAL OF A LICENSE.
- 16 (2) IF THE BOARD DETERMINES THAT THE APPLICATION OF THE
- 17 INDIVIDUAL SATISFIES THE REQUIREMENTS OF SUBSECTION (1) AND THAT
- 18 THE INDIVIDUAL MEETS THE REQUIREMENTS FOR A LICENSE AS PRESCRIBED
- 19 BY THIS ARTICLE AND RULES PROMULGATED UNDER THIS ARTICLE, THE BOARD
- 20 SHALL GRANT A SPECIAL VOLUNTEER LICENSE TO THE APPLICANT. A
- 21 LICENSEE SEEKING RENEWAL UNDER THIS SECTION SHALL PROVIDE THE BOARD
- 22 WITH AN UPDATED ACKNOWLEDGMENT AND DOCUMENTATION AS DESCRIBED UNDER
- 23 SUBSECTION (1)(B). EXCEPT AS OTHERWISE PROVIDED UNDER THIS
- 24 SUBSECTION, THE BOARD SHALL NOT CHARGE A FEE FOR THE ISSUANCE OR
- 25 RENEWAL OF A SPECIAL VOLUNTEER LICENSE UNDER THIS SECTION.
- 26 (3) EXCEPT AS OTHERWISE PROVIDED UNDER THIS SUBSECTION, A
- 27 PHYSICIAN WHO IS GRANTED A SPECIAL VOLUNTEER LICENSE PURSUANT TO

- THIS SECTION AND WHO ACCEPTS THE PRIVILEGE OF PRACTICING MEDICINE 1
- 2 IN THIS STATE IS SUBJECT TO ALL OF THE PROVISIONS OF THIS ARTICLE,
- 3 INCLUDING THOSE PROVISIONS CONCERNING CONTINUING EDUCATION AND
- DISCIPLINARY ACTION.
- (4) FOR PURPOSES OF THIS SECTION, AN INDIVIDUAL IS CONSIDERED 5
- RETIRED FROM PRACTICE IF THE INDIVIDUAL'S LICENSE HAS EXPIRED WITH 6
- THE INDIVIDUAL'S INTENTION OF CEASING TO ENGAGE IN THE PRACTICE OF 7
- MEDICINE OR OSTEOPATHIC MEDICINE AND SURGERY FOR REMUNERATION. 8
