## SUBSTITUTE FOR HOUSE BILL NO. 4778

A bill to amend 1994 PA 451, entitled "Natural resources and environmental protection act," (MCL 324.101 to 324.90106) by adding section 44520a.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 44520A. (1) AN OWNER OF A NONMOTORIZED LIVERY BOAT IS NOT
- 2 LIABLE FOR AN INJURY TO OR THE DEATH OF A USER OF THE NONMOTORIZED
- 3 LIVERY BOAT RESULTING FROM A RISK INHERENT IN THE USE OR OPERATION
- 4 OF A NONMOTORIZED LIVERY BOAT.
- 5 (2) AS USED IN THIS SECTION:
- 6 (A) "OWNER OF A NONMOTORIZED LIVERY BOAT" MEANS THE PERSON WHO
- 7 OWNS THE NONMOTORIZED LIVERY BOAT, THE BOAT LIVERY THAT RENTS,
- 8 LEASES, OR FURNISHES THE NONMOTORIZED LIVERY BOAT FOR USE, OR AN
- 9 EMPLOYEE OR AGENT OF THE OWNER OR BOAT LIVERY.
- 10 (B) "RISK INHERENT IN THE USE OR OPERATION OF A NONMOTORIZED

- 1 LIVERY BOAT" MEANS A DANGER OR CONDITION THAT IS AN INTEGRAL PART
- 2 OF THE USE OR OPERATION OF A NONMOTORIZED LIVERY BOAT THAT IS
- 3 LIMITED TO 1 OR MORE OF THE FOLLOWING:
- 4 (i) WAVE OR OTHER WATER MOTION.
- 5 (ii) WEATHER CONDITIONS.
- 6 (iii) CONTACT OR MANEUVERS NECESSARY TO AVOID CONTACT WITH
- 7 ANOTHER VESSEL OR A MANMADE OBJECT IN OR NEAR THE WATER.
- 8 (iv) CONTACT OR MANEUVERS NECESSARY TO AVOID CONTACT WITH ROCK,
- 9 SAND, VEGETATION, OR OTHER NATURAL OBJECTS IN OR NEAR THE WATER.
- 10 (v) MALFUNCTION OF EQUIPMENT, EXCEPT FOR EQUIPMENT OWNED BY
- 11 THE OWNER OF A NONMOTORIZED LIVERY BOAT.
- 12 (vi) FAILURE TO USE OR WEAR A PERSONAL FLOTATION DEVICE OR TO
- 13 HAVE LIFESAVING EQUIPMENT AVAILABLE, EXCEPT IF THE OWNER OF A
- 14 NONMOTORIZED LIVERY BOAT FAILED TO PROVIDE THE PERSONAL FLOTATION
- 15 DEVICE OR LIFESAVING EQUIPMENT WHEN REQUIRED BY LAW OR REGULATION
- 16 TO DO SO.
- 17 (vii) THE ACTIONS OF A VESSEL OPERATOR, EXCEPT IF THE OWNER OF
- 18 A NONMOTORIZED LIVERY BOAT LEASED OR RENTED THE LIVERY BOAT TO AN
- 19 OPERATOR WHO THE OWNER KNEW OR IN THE EXERCISE OF REASONABLE CARE
- 20 SHOULD HAVE KNOWN WAS DISQUALIFIED BY LAW OR REGULATION FROM
- 21 OPERATING THE LIVERY BOAT.
- 22 (viii) HAVING A NUMBER OF PERSONS IN EXCESS OF THE MAXIMUM
- 23 NUMBER APPROVED FOR THE LIVERY BOAT ON BOARD, EXCEPT IF THE OWNER
- 24 OF A NONMOTORIZED LIVERY BOAT KNOWINGLY ALLOWED THE LIVERY BOAT TO
- 25 LEAVE THE BOAT LIVERY'S PREMISES WITH A NUMBER OF PERSONS IN EXCESS
- 26 OF THE MAXIMUM WEIGHT OR NUMBER APPROVED FOR THE LIVERY BOAT ON
- 27 BOARD OR DID NOT PROPERLY INFORM THE USER OF THE MAXIMUM WEIGHT OR

- NUMBER OF PERSONS APPROVED FOR THE LIVERY BOAT. 1
- 2 (C) "USER OF THE NONMOTORIZED LIVERY BOAT" MEANS A PERSON WHO
- 3 PARTICIPATES IN THE USE OR OPERATION OF THE NONMOTORIZED LIVERY
- BOAT REGARDLESS OF WHETHER THE PERSON RENTED OR LEASED THE
- 5 NONMOTORIZED LIVERY BOAT.
