SUBSTITUTE FOR HOUSE BILL NO. 4838

A bill to amend 1984 PA 431, entitled "The management and budget act,"

(MCL 18.1101 to 18.1594) by adding section 1299.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 1299. (1) THE OFFICE OF THE STATE BUDGET DIRECTOR SHALL
- 2 DO ALL OF THE FOLLOWING:
- 3 (A) ESTABLISH, MAINTAIN, AND COORDINATE THE STATE HIGHER
- 4 EDUCATION DATABASE COMMONLY KNOWN AS THE HIGHER EDUCATION
- 5 INSTITUTIONAL DATA INVENTORY OR "HEIDI".
- 6 (B) COLLECT DATA CONCERNING PUBLIC UNIVERSITIES AND PUBLIC
- 7 UNIVERSITY PROGRAMS IN THIS STATE, INCLUDING DATA REQUIRED BY LAW,
- 8 AND INCLUDE IT IN THE DATABASE.
- 9 (C) ESTABLISH PROCEDURES TO ENSURE THE VALIDITY AND

- 1 RELIABILITY OF THE DATA AND THE COLLECTION PROCESS.
- 2 (D) DEVELOP MODEL DATA COLLECTION POLICIES, INCLUDING, BUT NOT
- 3 LIMITED TO, POLICIES THAT ENSURE THE PRIVACY OF INDIVIDUAL STUDENT
- 4 DATA. PRIVACY POLICIES SHALL ENSURE THAT STUDENT SOCIAL SECURITY
- 5 NUMBERS ARE NOT RELEASED TO THE PUBLIC FOR ANY PURPOSE.
- 6 (E) PROVIDE DATA IN A USEFUL MANNER TO ALLOW STATE
- 7 POLICYMAKERS AND PUBLIC UNIVERSITY OFFICIALS TO MAKE INFORMED
- 8 POLICY DECISIONS.
- 9 (F) ASSIST PUBLIC UNIVERSITIES IN COMPLYING WITH AUDITS UNDER
- 10 THIS SECTION OR FEDERAL LAW.
- 11 (G) PERFORM OTHER FUNCTIONS ASSIGNED BY THE STATE BUDGET
- 12 DIRECTOR OR REQUIRED BY LAW.
- 13 (2) THERE IS CREATED WITHIN THE OFFICE OF THE STATE BUDGET
- 14 DIRECTOR IN THE DEPARTMENT THE HIGHER EDUCATION INSTITUTIONAL DATA
- 15 INVENTORY ADVISORY COMMITTEE. THE COMMITTEE SHALL PROVIDE ADVICE TO
- 16 THE STATE BUDGET DIRECTOR REGARDING THE MANAGEMENT OF THE STATE
- 17 HIGHER EDUCATION DATABASE, INCLUDING, BUT NOT LIMITED TO:
- 18 (A) DETERMINING WHAT DATA IS NECESSARY TO COLLECT AND
- 19 MAINTAIN.
- 20 (B) DEFINING THE ROLES OF ALL STAKEHOLDERS IN THE DATA
- 21 COLLECTION SYSTEM.
- 22 (C) RECOMMENDING TIMELINES FOR THE IMPLEMENTATION AND ONGOING
- 23 COLLECTION OF DATA.
- 24 (D) ESTABLISHING AND MAINTAINING DATA DEFINITIONS, DATA
- 25 TRANSMISSION PROTOCOLS, AND SYSTEM SPECIFICATIONS AND PROCEDURES
- 26 FOR THE EFFICIENT AND ACCURATE TRANSMISSION AND COLLECTION OF DATA.
- 27 (E) ESTABLISHING AND MAINTAINING A PROCESS FOR ENSURING THE

- 1 ACCURACY OF THE DATA.
- 2 (F) ESTABLISHING AND MAINTAINING POLICIES RELATED TO DATA
- 3 COLLECTION, INCLUDING, BUT NOT LIMITED TO, PRIVACY POLICIES RELATED
- 4 TO INDIVIDUAL STUDENT DATA.
- 5 (G) ENSURING THE DATA IS MADE AVAILABLE TO STATE POLICYMAKERS
- 6 AND CITIZENS OF THIS STATE IN THE MOST USEFUL FORMAT POSSIBLE.
- 7 (H) ADDRESSING OTHER MATTERS AS DETERMINED BY THE STATE BUDGET
- 8 DIRECTOR OR AS REQUIRED BY LAW.
- 9 (3) THE HIGHER EDUCATION INSTITUTIONAL DATA INVENTORY ADVISORY
- 10 COMMITTEE CREATED IN SUBSECTION (2) SHALL CONSIST OF THE FOLLOWING
- 11 MEMBERS:
- 12 (A) ONE REPRESENTATIVE FROM THE HOUSE FISCAL AGENCY, APPOINTED
- 13 BY THE DIRECTOR OF THE HOUSE FISCAL AGENCY.
- 14 (B) ONE REPRESENTATIVE FROM THE SENATE FISCAL AGENCY,
- 15 APPOINTED BY THE DIRECTOR OF THE SENATE FISCAL AGENCY.
- 16 (C) ONE REPRESENTATIVE FROM THE OFFICE OF THE STATE BUDGET
- 17 DIRECTOR, APPOINTED BY THE STATE BUDGET DIRECTOR.
- 18 (D) THREE REPRESENTATIVES OF THE PRESIDENTS COUNCIL OF STATE
- 19 UNIVERSITIES, APPOINTED BY THE PRESIDENTS COUNCIL. THE PRESIDENTS
- 20 COUNCIL SHALL APPOINT 1 REPRESENTATIVE EACH FROM A MASTER'S
- 21 UNIVERSITY, A DOCTORAL UNIVERSITY, AND A RESEARCH UNIVERSITY.
- 22 (4) THE AUDITOR GENERAL SHALL REVIEW HIGHER EDUCATION
- 23 INSTITUTIONAL DATA INVENTORY ENROLLMENT DATA SUBMITTED BY ALL
- 24 PUBLIC UNIVERSITIES AND SHALL PERFORM AUDITS OF SELECTED DATA
- 25 SUBMITTED BY PUBLIC UNIVERSITIES. THE REVIEW AND AUDITS SHALL BE
- 26 BASED UPON THE DEFINITIONS, REQUIREMENTS, AND UNIFORM REPORTING
- 27 CATEGORIES ESTABLISHED BY THE STATE BUDGET DIRECTOR IN CONSULTATION

- 1 WITH THE HIGHER EDUCATION INSTITUTIONAL DATA INVENTORY ADVISORY
- 2 COMMITTEE. THE AUDITOR GENERAL SHALL SUBMIT AN ANNUAL REPORT OF
- FINDINGS TO THE HOUSE AND SENATE APPROPRIATIONS COMMITTEES AND THE 3
- STATE BUDGET DIRECTOR BY JULY 1 OF EACH YEAR.
