## SUBSTITUTE FOR HOUSE BILL NO. 4889

A bill to amend 1949 PA 300, entitled "Michigan vehicle code,"

by amending section 733 (MCL 257.733), as amended by 2004 PA 62.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 733. (1) The department shall not release information
- 2 relating to an accident on the record of a driver to a
- 3 nongovernmental agency unless the driver was subsequently convicted
- 4 of or determined responsible for a violation of this act in
- 5 connection with the accident.
- 6 (2) The EXCEPT AS OTHERWISE PROVIDED IN SUBSECTION (4), THE
- 7 department shall not release information relating to an accident on
- 8 the record of -a police officer, fire fighter, or a person
- 9 authorized to operate an ambulance or other emergency vehicle ANY

- 1 OF THE FOLLOWING to a nongovernmental agency if the accident
- 2 occurred while the person was operating the vehicle during the
- 3 course of his or her employment: —
- 4 (A) A POLICE OFFICER.
- 5 (B) A FIREFIGHTER.
- 6 (C) AN EMPLOYEE OF THE STATE TRANSPORTATION DEPARTMENT, A
- 7 COUNTY ROAD COMMISSION, OR A LOCAL AUTHORITY HAVING JURISDICTION
- 8 OVER A HIGHWAY WHO IS AUTHORIZED TO OPERATE A MOTOR VEHICLE OR
- 9 EQUIPMENT WHILE WORKING WITHIN THE HIGHWAY RIGHT-OF-WAY.
- 10 (D) A PERSON AUTHORIZED TO OPERATE AN AMBULANCE OR OTHER
- 11 EMERGENCY VEHICLE.
- 12 (3) The department shall not release information received
- 13 under section 732(5) concerning a plea to and the discharge and
- 14 dismissal of a violation of section 703 of the Michigan liquor
- 15 control code of 1998, 1998 PA 58, MCL 436.1703, or a local
- 16 ordinance substantially corresponding to section 703 of the
- 17 Michigan liquor control code of 1998, 1998 PA 58, MCL 436.1703,
- 18 except as provided in section 703(3) of the Michigan liquor control
- 19 code of 1998, 1998 PA 58, MCL 436.1703.
- 20 (4) SUBSECTION (2) DOES NOT APPLY TO A PERSON DESCRIBED IN
- 21 SUBSECTION (2) WHO WAS CONVICTED OF A CRIME UNDER THIS ACT IN
- 22 CONNECTION WITH THE ACCIDENT.
