SUBSTITUTE FOR HOUSE BILL NO. 4971

A bill to amend 1975 PA 228, entitled "Single business tax act,"

(MCL 208.1 to 208.145) by adding section 32.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 32. (1) FOR TAX YEARS THAT BEGIN ON OR AFTER JANUARY 1,
- 2 2006 AND END BEFORE JANUARY 1, 2016, A TAXPAYER THAT IS ENGAGED IN
- 3 RESEARCH AND DEVELOPMENT OF A QUALIFIED TECHNOLOGY MAY CLAIM A
- 4 CREDIT AGAINST THE TAX IMPOSED BY THIS ACT EQUAL TO 3.9% OF THE
- 5 COMPENSATION AS DEFINED IN SECTION 4 FOR SERVICES PERFORMED IN A
- 6 QUALIFIED FACILITY, PAID TO THE EMPLOYEES AT THE QUALIFIED FACILITY
- 7 IN THE TAX YEAR, IF THE TAXPAYER HAS ENTERED INTO AN AGREEMENT
- 8 BEFORE JANUARY 1, 2007 WITH THE MICHIGAN ECONOMIC GROWTH AUTHORITY
- 9 THAT PROVIDES ALL OF THE FOLLOWING:

- House Bill No. 4971 (H-2) as amended June 21, 2006
- 1 (A) THE TYPE AND NUMBER OF JOBS AT THE QUALIFIED FACILITY TO
- 2 WHICH THE AGREEMENT APPLIES.
- 3 (B) THE TYPE OF WORK TO BE PERFORMED BY THE EMPLOYEES
- 4 PERFORMING THE JOBS PROVIDED UNDER SUBDIVISION (A) BY THE TAXPAYER.
- 5 (C) ANY OTHER TERMS AND CONDITIONS THAT THE MICHIGAN ECONOMIC
- 6 GROWTH AUTHORITY CONSIDERS TO BE IN THE PUBLIC INTEREST.
- 7 (2) IF THE CREDIT ALLOWED UNDER THIS SECTION EXCEEDS THE TAX
- 8 LIABILITY OF THE TAXPAYER FOR THE TAX YEAR, THAT PORTION THAT
- 9 EXCEEDS THE TAX LIABILITY SHALL BE REFUNDABLE.
- 10 (3) THE MAXIMUM AMOUNT OF THE CREDIT [ALLOWED UNDER THIS SECTION THAT] ANY 1 TAXPAYER MAY CLAIM
- 11 SHALL NOT EXCEED \$3,000,000.00 IN A SINGLE TAX YEAR.
- 12 (4) AS USED IN THIS SECTION:
- 13 (A) "MICHIGAN ECONOMIC GROWTH AUTHORITY" MEANS THE MICHIGAN
- 14 ECONOMIC GROWTH AUTHORITY CREATED IN THE MICHIGAN ECONOMIC GROWTH
- 15 AUTHORITY ACT, 1995 PA 24, MCL 207.801 TO 207.810.
- 16 (B) "MOTOR VEHICLE" MEANS A MOTOR VEHICLE AS DEFINED IN
- 17 SECTION 33 OF THE MICHIGAN VEHICLE CODE, 1949 PA 300, MCL 257.33,
- 18 THAT IS DESIGNED AS A PASSENGER VEHICLE, OR SPORT UTILITY VEHICLE,
- 19 BUT DOES NOT INCLUDE A MOTOR HOME, BUS, TRUCK OTHER THAN A PICKUP
- 20 TRUCK OR VAN, OR A VEHICLE DESIGNED TO TRAVEL ON LESS THAN 4
- 21 WHEELS.
- 22 (C) "QUALIFIED CITY" MEANS A CITY THAT MEETS BOTH OF THE
- 23 FOLLOWING CRITERIA:
- 24 (i) HAS A POPULATION OF NOT LESS THAN 80,000 AND NOT MORE THAN
- 25 82,000 AS DESIGNATED BY THE UNITED STATES BUREAU OF THE CENSUS IN
- 26 THE 2000 CENSUS.
- 27 (ii) IS LOCATED IN A COUNTY THAT HAS A POPULATION OF NOT LESS

- THAN 1,000,000 AND NOT MORE THAN 1,300,000 AS DESIGNATED BY THE 1
- 2 UNITED STATES BUREAU OF THE CENSUS IN THE 2000 CENSUS.
- (D) "QUALIFIED FACILITY" MEANS A LEASED FACILITY IN A 3
- 4 QUALIFIED CITY USED EXCLUSIVELY FOR THE RESEARCH AND DEVELOPMENT OF
- 5 A QUALIFIED TECHNOLOGY.
- (E) "QUALIFIED TECHNOLOGY" MEANS A 2-MODE HYBRID SYSTEM THE 6
- PRIMARY PURPOSE OF WHICH IS THE PROPULSION OF A MOTOR VEHICLE. 7
- (F) "RESEARCH AND DEVELOPMENT" MEANS "QUALIFIED RESEARCH" AS 8
- THAT TERM IS DEFINED IN SECTION 41(D) OF THE INTERNAL REVENUE CODE. 9
