SUBSTITUTE FOR HOUSE BILL NO. 5109

A bill to amend 2000 PA 489, entitled "Michigan trust fund act,"

by amending the title and section 2 (MCL 12.252), and by adding sections 7 and 8; and to repeal acts and parts of acts.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 2 An act to create certain funds; to provide for the ALLOCATION

- 10 (E) "RESIDUAL TOBACCO SETTLEMENT REVENUE" MEANS ANY RESIDUAL
- 11 INTERESTS, AS DEFINED BY THE MICHIGAN TOBACCO SETTLEMENT FINANCE
- 12 AUTHORITY, THAT ARE RECEIVED BY THIS STATE.
- (F) -(d) "Tobacco settlement revenue" means money received by
- 14 this state that is attributable to the master settlement agreement
- 15 incorporated into a consent decree and final judgment entered into
- on December 7, 1998 in Kelly Ex Rel. Michigan v Philip Morris
- 17 Incorporated, et al., Ingham county circuit court, docket no. 96-
- 18 84281CZ, AND THAT IS NOT TSRS AS THAT TERM IS DEFINED UNDER THE
- 19 MICHIGAN TOBACCO SETTLEMENT FINANCE AUTHORITY ACT.
- 20 (G) (e) "Tobacco settlement trust fund" means the Michigan
- 21 tobacco settlement trust fund established in section 3.
- 22 (H) "21ST CENTURY JOBS TRUST FUND" MEANS THE 21ST CENTURY JOBS
- 23 TRUST FUND ESTABLISHED IN SECTION 7.
- 24 SEC. 7. (1) THE 21ST CENTURY JOBS TRUST FUND IS ESTABLISHED IN
- 25 THE DEPARTMENT OF TREASURY. THE 21ST CENTURY JOBS TRUST FUND SHALL
- 26 CONSIST ONLY OF INTEREST AND EARNINGS FROM 21ST CENTURY JOBS TRUST
- 27 FUND INVESTMENTS, DONATIONS OF MONEY MADE TO THE 21ST CENTURY JOBS

- 1 TRUST FUND FROM ANY SOURCE, AND THE NET PROCEEDS OF THE SALE OF
- 2 TOBACCO SETTLEMENT REVENUES TO THE TOBACCO SETTLEMENT FINANCE

- 4 (2) THE STATE TREASURER SHALL DIRECT THE INVESTMENT OF THE
- 5 21ST CENTURY JOBS TRUST FUND, WHICH MAY BE INVESTED AS PART OF THE
- 6 COMMON CASH OF THE STATE BUT SHALL BE SEPARATELY ACCOUNTED FOR BY
- 7 THE STATE TREASURER. THE STATE TREASURER MAY INVEST THE ASSETS OF
- 8 THE 21ST CENTURY JOBS TRUST FUND IN ANY INVESTMENT AUTHORIZED UNDER
- 9 1855 PA 105, MCL 21.141 TO 21.147, FOR SURPLUS FUNDS OF THIS STATE,
- 10 IN OBLIGATIONS ISSUED BY ANY STATE OR POLITICAL SUBDIVISION OR

- 12 ASSUMED, OR GUARANTEED BY A SOLVENT ENTITY CREATED OR EXISTING
- 13 UNDER THE LAWS OF THE UNITED STATES OR OF ANY STATE, DISTRICT, OR
- 14 TERRITORY OF THE UNITED STATES, WHICH ARE NOT IN DEFAULT AS TO
- 15 PRINCIPAL OR INTEREST.
- 16 SEC. 8. (1) THE MICHIGAN MERIT AWARD TRUST FUND IS ESTABLISHED
- 17 IN THE DEPARTMENT OF TREASURY. THE MICHIGAN MERIT AWARD TRUST FUND
- 18 SHALL CONSIST ONLY OF INTEREST AND EARNINGS FROM MICHIGAN MERIT
- 19 AWARD TRUST FUND INVESTMENTS, DONATIONS OF MONEY MADE TO THE TRUST
- 20 FUND FROM ANY SOURCE, AND ANY MONEY ALLOCATED AS PROVIDED BY LAW.
- 21 (2) MONEY IN THE MICHIGAN MERIT AWARD TRUST FUND AT THE CLOSE
- 22 OF A FISCAL YEAR SHALL REMAIN IN THE MICHIGAN MERIT AWARD TRUST
- 23 FUND AND SHALL NOT REVERT TO THE GENERAL FUND.
- 24 (3) THE STATE TREASURER SHALL DIRECT THE INVESTMENT OF THE
- 25 MICHIGAN MERIT AWARD TRUST FUND.
- 26 (4) UPON APPROPRIATION, THE STATE TREASURER SHALL DISBURSE
- 27 FUNDS FROM THE MICHIGAN MERIT AWARD TRUST FUND FOR 1 OR MORE OF THE

- 1 FOLLOWING PURPOSES:
- 2 (A) MICHIGAN MERIT AWARD SCHOLARSHIPS UNDER THE MICHIGAN MERIT
- 3 AWARD SCHOLARSHIP ACT, 1999 PA 94, MCL 390.1451 TO 390.1459.
- 4 (B) EXPENSES PROPERLY INCURRED IN THE ADMINISTRATION OF THE
- 5 MICHIGAN MERIT AWARD SCHOLARSHIPS AND ANY TEST BY WHICH AWARDEES OF
- 6 THE MICHIGAN MERIT AWARD SCHOLARSHIPS ARE DETERMINED.
- 7 Enacting section 1. Sections 3 and 5 of the Michigan merit
- 8 award scholarship act, 1999 PA 94, MCL 390.1453 and 390.1455, are
- 9 repealed.
- 10 Enacting section 2. This amendatory act takes effect October
- **11** 1, 2005.
- 12 Enacting section 3. This amendatory act does not take effect
