## SUBSTITUTE FOR HOUSE BILL NO. 5204

A bill to amend 1933 PA 167, entitled "General sales tax act,"

(MCL 205.51 to 205.78) by adding section 4cc.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 4CC. (1) EXCEPT AS OTHERWISE PROVIDED IN SUBSECTION (2),
- 2 A PERSON WHO IS A MOTION PICTURE PRODUCTION COMPANY MAY CLAIM A
- 3 CREDIT AS PROVIDED UNDER SECTION 35E OF THE SINGLE BUSINESS TAX
- 4 ACT, 1975 PA 228, MCL 208.35E, EQUAL TO THE AMOUNT OF TAX THAT THE
- 5 PERSON PAID TO REIMBURSE A TAXPAYER AS PROVIDED IN SECTION 23 FOR
- 6 SALES TAX PAID ON A SALE AT RETAIL TO THAT PERSON IF ALL OF THE
- 7 FOLLOWING APPLY:
- 8 (A) THE MOTION PICTURE PRODUCTION COMPANY HAS SPENT
- 9 \$250,000.00 OR MORE IN THIS STATE FOR PURPOSES RELATED TO THE

- 1 FILMING OR PRODUCTION OF A SINGLE MOTION PICTURE.
- 2 (B) THE TANGIBLE PERSONAL PROPERTY PURCHASED BY THE MOTION
- 3 PICTURE PRODUCTION COMPANY IS USED EXCLUSIVELY AS AN INTEGRAL PART
- 4 OF THE PRODUCTION ACTIVITIES IN THIS STATE.
- 5 (2) A PERSON WHO IS A MOTION PICTURE PRODUCTION COMPANY IS NOT
- 6 ELIGIBLE FOR THE CREDIT UNDER SUBSECTION (1) IF THE MOTION PICTURE
- 7 OR PRODUCTION ACTIVITIES ON WHICH THE CREDIT IS BASED DEPICT
- 8 OBSCENE MATTER OR AN OBSCENE PERFORMANCE.
- 9 (3) AS USED IN THIS SECTION:
- 10 (A) "MOTION PICTURE" MEANS A FEATURE-LENGTH FILM DISTRIBUTED
- 11 IN 2 OR MORE STATES THAT IS A PRODUCTION FOR WHICH RECORDS ARE NOT
- 12 REOUIRED TO BE MAINTAINED WITH RESPECT TO ANY PERFORMER IN THE
- 13 PRODUCTION UNDER 18 USC 2257, OR TELEVISION SERIES OR COMMERCIAL
- 14 MADE IN THIS STATE, IN WHOLE OR IN PART, FOR THEATRICAL OR
- 15 TELEVISION VIEWING OR AS A TELEVISION PILOT. MOTION PICTURE DOES
- 16 NOT INCLUDE THE PRODUCTION OF TELEVISION COVERAGE OF NEWS OR
- 17 SPORTING EVENTS.
- 18 (B) "MOTION PICTURE PRODUCTION COMPANY" MEANS A COMPANY IN THE
- 19 BUSINESS OF PRODUCING MOTION PICTURES. HOWEVER, MOTION PICTURE
- 20 PRODUCTION COMPANY DOES NOT INCLUDE A COMPANY OWNED, AFFILIATED, OR
- 21 CONTROLLED, IN WHOLE OR IN PART, BY A COMPANY OR INDIVIDUAL THAT IS
- 22 IN DEFAULT ON A LOAN MADE BY THE STATE OR A LOAN GUARANTEED BY THE
- 23 STATE.
- 24 (C) "OBSCENE MATTER OR AN OBSCENE PERFORMANCE" MEANS MATTER
- 25 DESCRIBED IN 1984 PA 343, MCL 752.361 TO 752.374.
- 26 (4) THIS SECTION APPLIES ONLY TO A MOTION PICTURE PRODUCTION
- 27 COMPANY THAT BEGINS PRODUCTION OF A MOTION PICTURE AFTER JULY 1,
