A bill to amend 1999 PA 94, entitled

"Michigan merit award scholarship act,"

by amending section 8 (MCL 390.1458), as amended by 2004 PA 595.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 8. (1) Michigan merit award scholarship money shall be
- 2 used only to pay for eligible costs.
- 3 (2) The board shall determine the manner and form of
- 4 application for payment of a Michigan merit award scholarship by a
- 5 student eligible under this act and the procedure for payment to
- 6 the student or to an approved postsecondary educational
- 7 institution on the student's behalf, subject to 1 of the following,
- 8 as applicable:

(a) As determined by the board, upon the request of a student

- 1 or parent or legal guardian of a minor student, the board may pay a
- 2 Michigan merit award scholarship in 2 consecutive annual
- 3 installments rather than 1 lump sum for a student who graduates
- 4 from high school or passes the general educational development
- 5 (GED) test or approved graduate equivalency examination before
- 6 March 1, 2003.
- 7 (b) For each student who graduates from high school or passes
- 8 the general educational development (GED) test or approved graduate
- 9 equivalency examination on or after March 1, 2003 and before March
- 10 1, 2004, the board shall pay a Michigan merit award scholarship in
- 11 2 consecutive annual installments, beginning in the state fiscal
- 12 year for which the student is otherwise eligible. The first
- 13 installment shall not exceed 50% of the award amount, and the
- 14 second installment shall consist of the remaining award amount.
- 15 Verification that the student has met the enrollment criteria under
- 16 section 7b(1)(c) is required before payment of the second
- 17 installment.
- 18 (c) For each student who graduates from high school or passes
- 19 the general educational development (GED) test or approved graduate
- 20 equivalency examination on or after March 1, 2004, the board shall
- 21 pay a Michigan merit award scholarship in 2 consecutive annual
- 22 installments, beginning in the state fiscal year that begins after
- 23 the beginning of the academic year for which the student is
- 24 otherwise eligible. The first installment shall not exceed 50% of
- 25 the award amount, and the second installment shall consist of the
- 26 remaining award amount. Verification that the student has met the
- 27 enrollment criteria under section 7b(1)(c) is required before

- 1 payment of the second installment.
- 2 (3) An approved postsecondary educational institution shall
- 3 not consider a Michigan merit award scholarship in determining a
- 4 student's eligibility for a financial aid program administered by
- 5 this state. It is the intent of the legislature that an approved
- 6 postsecondary educational institution not reduce institutionally-
- 7 funded student aid because of the Michigan merit award scholarship
- 8 program.
- **9** (4) Before payment of a Michigan merit award scholarship to -a
- 10 student or an approved postsecondary educational institution ON
- 11 BEHALF OF A STUDENT, the student shall certify or affirm in writing
- 12 to the board each of the following:
- 13 (a) That the student is enrolled at an approved postsecondary
- 14 educational institution.
- 15 (b) The name of the approved postsecondary educational
- 16 institution in which the student is enrolled.
- 17 (c) That the student agrees to use the Michigan merit award
- 18 scholarship only for eligible costs.
- 19 (d) That the student has not been convicted of a felony
- 20 involving an assault, physical injury, or death.
- 21 (e) That the student graduated from high school or passed the
- 22 general educational development (GED) test or approved graduate
- 23 equivalency examination within 1 of the following time periods:
- 24 (i) If the student graduated from high school or passed the
- 25 test or examination before March 1, 2002, within the 7-year period
- 26 preceding the date of the student's application to receive his or
- 27 her Michigan merit award scholarship.

- $\mathbf{1}$ (ii) If the student graduated on or after March 1, 2002, within
- 2 the 4-year period preceding the date of the student's application
- 3 to receive his or her Michigan merit award scholarship, or within a
- 4 period equal to 4 years plus the number of days the student served
- 5 as a member of the United States armed forces or peace corps if the
- 6 student became a member of the United States armed forces or peace
- 7 corps during this 4-year period and served for 4 years or less. The
- 8 board may also extend the 4-year period if the board determines
- 9 that an extension is warranted because of an illness or disability
- 10 of the student or in the student's immediate family or another
- 11 family emergency.
- 12 (5) The board shall not begin disbursing funds for a Michigan
- 13 merit award scholarship to -a student or an approved postsecondary
- 14 educational institution on behalf of -the- A student unless it
- 15 receives the request or application for payment, including the
- 16 written certification or affirmation described in this section,
- 17 from the student on or before 1 of the following dates, for
- 18 disbursement in that academic year:
- **19** (a) In the 2002-2003 academic year, January 15.
- 20 (b) In the 2003-2004 academic year, September 15 if the
- 21 student received notification of eligibility prior to August 1.
- (c) In the 2003-2004 academic year, November 15 if the student
- 23 received notification of eligibility on or after August 1.
- 24 (d) In the 2004-2005 academic year, December 15.
- (e) In any other academic year, November 15.
- 26 (6) THE BOARD SHALL PAY ALL MICHIGAN MERIT AWARD SCHOLARSHIP
- 27 MONEY AWARDED UNDER THIS ACT TO THE APPROVED POSTSECONDARY

- 1 EDUCATIONAL INSTITUTION IN WHICH THE ELIGIBLE STUDENT IS ENROLLED.
- 2 THE EDUCATIONAL INSTITUTION SHALL DEPOSIT THE MONEY IN AN ACCOUNT
- 3 FOR THE BENEFIT OF THE STUDENT AND DISBURSE MONEY FROM THE ACCOUNT
- 4 FOR PAYMENT OF ELIGIBLE COSTS.
- 5 (7) IF A STUDENT ELECTS TO LEAVE AN APPROVED POSTSECONDARY
- 6 EDUCATIONAL INSTITUTION WITHOUT COMPLETING THE CLASSES IN WHICH HE
- 7 OR SHE ENROLLED, THE APPROVED POSTSECONDARY EDUCATIONAL INSTITUTION
- 8 SHALL RETURN ANY MONEY REMAINING IN THE STUDENT'S ACCOUNT DESCRIBED
- 9 IN SUBSECTION (5) TO THE DEPARTMENT OF TREASURY. THE DEPARTMENT
- 10 SHALL DEPOSIT THE MONEY RETURNED FROM THE STUDENT'S ACCOUNT INTO AN
- 11 ACCOUNT IN THE STATE TREASURY FOR THE STUDENT. ANY MONEY REMAINING
- 12 IN AN ACCOUNT FOR 5 YEARS SHALL ESCHEAT TO THE STATE.
