THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 28. (1) Those electors of the township appointed by the
- 2 township board shall constitute a board of review for the township.
- 3 At least 2/3 of the members shall be property taxpayers of the
- 4 township. Members appointed to the board of review shall serve for
- 5 terms of 2 years beginning at noon on January 1 of each odd-
- 6 numbered year. Each member of the board of review shall qualify by
 - taking the constitutional oath of office within 10 days after
- appointment. The township board may fill any vacancy that occurs in
- 9 the membership of the board of review. A member of the township
- 10 board is not eligible to serve on the board or to fill any vacancy.

AN ALTERNATE MEMBER MAY ALSO BE CALLED TO PERFORM THE DUTIES OF A REGULAR MEMBER OF THE BOARD OF REVIEW FOR THE PURPOSE OF REACHING A DECISION IN ISSUES PROTESTED IN WHICH A REGULAR MEMBER HAS ABSTAINED FOR REASONS OF CONFLICT OF INTEREST.]
