A bill to amend 1994 PA 451, entitled "Natural resources and environmental protection act," (MCL 324.101 to 324.90106) by adding section 43540c.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 43540C. (1) SUBJECT TO SUBSECTION (2), WHEN A PERSON
- 2 APPLIES FOR A LICENSE UNDER THIS PART, THE DEPARTMENT OR THE
- 3 DEPARTMENT'S AGENT SHALL ASK WHETHER THE PERSON WOULD LIKE TO
- 4 DONATE \$1.00 TO THE SPORTSMEN AGAINST HUNGER PROGRAM CREATED BY THE
- 5 DEPARTMENT UNDER SECTION 43540A AND, IF SO, SHALL COLLECT THE
- 6 DONATION WITH THE LICENSE FEE. A PERSON DESIGNATED BY THE
- 7 DEPARTMENT TO ISSUE LICENSES SHALL NOT RECEIVE A COMMISSION UNDER
- 8 SECTION 43541 FOR THE DONATION.
- 9 (2) SUBSECTION (1) APPLIES TO LICENSE APPLICATIONS MADE
- 10 BEGINNING JANUARY 1, 2006.

- 1 (3) A DONATION UNDER SUBSECTION (1) IS IN ADDITION TO THE
- 2 LICENSE FEE.
- 3 (4) THE DEPARTMENT SHALL TRANSFER DONATIONS UNDER SUBSECTION
- 4 (1) TO THE STATE TREASURER FOR DEPOSIT IN THE FUND.
- 5 (5) THE SPORTSMEN AGAINST HUNGER FUND IS CREATED WITHIN THE
- 6 STATE TREASURY.
- 7 (6) THE STATE TREASURER MAY RECEIVE MONEY OR OTHER ASSETS FROM
- 8 ANY SOURCE FOR DEPOSIT INTO THE FUND. THE STATE TREASURER SHALL
- 9 DIRECT THE INVESTMENT OF THE FUND. THE STATE TREASURER SHALL CREDIT
- 10 TO THE FUND INTEREST AND EARNINGS FROM FUND INVESTMENTS.
- 11 (7) MONEY IN THE FUND AT THE CLOSE OF THE FISCAL YEAR SHALL
- 12 REMAIN IN THE FUND AND SHALL NOT LAPSE TO THE GENERAL FUND.
- 13 (8) MONEY FROM THE FUND SHALL BE EXPENDED, UPON APPROPRIATION,
- 14 ONLY BY THE DEPARTMENT FOR 1 OR MORE OF THE FOLLOWING PURPOSES:
- 15 (A) THE COSTS OF ADMINISTERING THE FUND, INCLUDING THE COSTS
- 16 OF COLLECTING DONATIONS TO THE FUND.
- 17 (B) THE ADMINISTRATION OF THE SPORTSMEN AGAINST HUNGER PROGRAM
- 18 CREATED UNDER SECTION 43540A, INCLUDING, IF APPLICABLE, THE COSTS
- 19 OF ANY CONTRACT WITH A NONPROFIT ORGANIZATION TO ADMINISTER THE
- 20 SPORTSMEN AGAINST HUNGER PROGRAM, AS AUTHORIZED UNDER SECTION
- 21 43540A(4).
- 22 (9) THE DEPARTMENT SHALL NOT INCUR COSTS DESCRIBED IN
- 23 SUBSECTION (8) IN EXCESS OF THE AMOUNT OF REVENUE IN THE FUND
- 24 AVAILABLE TO COVER SUCH COSTS.
- 25 (10) AS USED IN THIS SECTION, "FUND" MEANS THE SPORTSMEN
- 26 AGAINST HUNGER FUND CREATED IN SUBSECTION (5).
- 27 Enacting section 1. This amendatory act does not take effect
