

# HOUSE BILL No. 4375

(As amended March 28, 2006)

February 23, 2005, Introduced by Reps. Ward, Accavitti, Anderson, Sak, Ball, Sheltroun, Moore, Bieda, Espinoza, Green, Rocca, Stahl, Gleason, Kathleen Law, Hopgood, Condino and Leland and referred to the Committee on Education.

A bill to amend 1976 PA 451, entitled  
"The revised school code,"  
(MCL 380.1 to 380.1852) by adding section 1171.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1           SEC. 1171. (1) THE BOARD OF A SCHOOL DISTRICT OR BOARD OF  
2           DIRECTORS OF A PUBLIC SCHOOL ACADEMY IS ENCOURAGED TO PROVIDE AGE-  
3           APPROPRIATE INSTRUCTION FOR PUPILS AND PROFESSIONAL DEVELOPMENT FOR  
4           SCHOOL PERSONNEL CONCERNING THE WARNING SIGNS AND RISK FACTORS FOR  
5           SUICIDE AND DEPRESSION [AND THE PROTECTIVE FACTORS THAT HELP PREVENT  
6           SUICIDE]. THE INSTRUCTION AND PROFESSIONAL  
7           DEVELOPMENT SHALL BE DESIGNED TO ACHIEVE THE FOLLOWING GOALS:  
8           (A) TO PREVENT BOTH FATAL AND NONFATAL SUICIDE BEHAVIORS AMONG  
9           YOUTH.  
10           (B) TO INCREASE PUPIL AWARENESS OF THE WARNING SIGNS AND RISK

1 FACTORS FOR SUICIDE AND DEPRESSION.

2 (C) TO IMPROVE ACCESS TO APPROPRIATE PREVENTION SERVICES FOR  
3 VULNERABLE YOUTH GROUPS.

4 (2) THE BOARD OF A SCHOOL DISTRICT OR BOARD OF DIRECTORS OF A  
5 PUBLIC SCHOOL ACADEMY IS ENCOURAGED TO WORK WITH SCHOOL PERSONNEL  
6 AND LOCAL OR STATE ORGANIZATIONS AND RESOURCES SPECIALIZING IN  
7 SUICIDE PREVENTION AND AWARENESS.

8 (3) THE DEPARTMENT SHALL DEVELOP OR SELECT MODEL PROGRAMS AND  
9 MATERIALS ON SUICIDE PREVENTION AND AWARENESS THAT ARE APPROPRIATE  
10 FOR THE PURPOSES OF THIS SECTION[, SUCH AS THE MICHIGAN MODEL FOR  
11 COMPREHENSIVE SCHOOL HEALTH EDUCATION,] AND SHALL MAKE THOSE MODEL  
12 PROGRAMS AND MATERIALS AVAILABLE TO SCHOOL DISTRICTS AND PUBLIC  
13 SCHOOL ACADEMIES.

14 (4) IF A SCHOOL DISTRICT OR PUBLIC SCHOOL ACADEMY PROVIDES  
15 INSTRUCTION DESCRIBED IN SUBSECTION (1), THE BOARD OF THE SCHOOL  
16 DISTRICT OR BOARD OF DIRECTORS OF THE PUBLIC SCHOOL ACADEMY SHALL  
17 NOTIFY THE PARENTS OF [ALL PUPILS OF EACH SCHOOL IN WHICH THE INSTRUCTION  
18 IS PROVIDED] ABOUT THE INSTRUCTION  
19 USING THE COMMUNICATION METHOD THE SCHOOL DISTRICT OR PUBLIC SCHOOL  
20 ACADEMY NORMALLY USES FOR REGULAR COMMUNICATIONS WITH PARENTS.

[ (5) FAILURE OF A SCHOOL DISTRICT OR PUBLIC SCHOOL ACADEMY TO  
COMPLY WITH SUBSECTION (4) DOES NOT CREATE A CAUSE OF ACTION OR  
CONSTITUTE A BREACH OF ANY LEGAL DUTY IN A CIVIL ACTION.]
