SUBSTITUTE FOR HOUSE BILL NO. 4403

A bill to amend 1978 PA 368, entitled "Public health code,"

by amending section 16215 (MCL 333.16215), as amended by 1999 PA 60.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 16215. (1) Subject to subsections (2) to $\frac{-(5)}{-(6)}$, a
- 2 licensee who holds a license other than a health profession
- 3 subfield license may delegate to a licensed or unlicensed
- 4 individual who is otherwise qualified by education, training, or
- 5 experience the performance of selected acts, tasks, or functions
- 6 where the acts, tasks, or functions fall within the scope of
- 7 practice of the licensee's profession and will be performed under
- 8 the licensee's supervision. A licensee shall not delegate an act,

- 1 task, or function under this section if the act, task, or function,
- 2 under standards of acceptable and prevailing practice, requires the
- 3 level of education, skill, and judgment required of the licensee
- 4 under this article.
- 5 (2) Subject to subsection (1) and except as otherwise provided
- 6 in this subsection and -subsection SUBSECTIONS (3) AND (4), a
- 7 licensee who is an allopathic physician or osteopathic physician
- 8 and surgeon shall delegate an act, task, or function that involves
- 9 the performance of a procedure that requires the use of surgical
- 10 instrumentation only to an individual who is licensed under this
- 11 article. A licensee who is an allopathic physician or osteopathic
- 12 physician and surgeon may delegate an act, task, or function
- 13 described in this subsection to an individual who is not licensed
- 14 under this article if the unlicensed individual is 1 or more of the
- 15 following and if the procedure is directly supervised by a licensed
- 16 allopathic physician or osteopathic physician and surgeon who is
- 17 physically present during the performance of the procedure:
- 18 (a) A student enrolled in a school of medicine or osteopathic
- 19 medicine approved by the Michigan board of medicine or the Michigan
- 20 board of osteopathic medicine and surgery.
- 21 (b) A student enrolled in a physician's assistant training
- 22 program approved by the joint physician's assistant task force
- 23 created under part 170.
- 24 (3) Subject to subsection (1), a licensee who is an allopathic
- 25 physician or osteopathic physician and surgeon may delegate an act,
- 26 task, or function described in subsection (2) to an individual who
- 27 is not licensed under this article and who is 1 of the following:

- 1 (a) Performing acupuncture.
- 2 (b) Surgically removing only bone, skin, blood vessels,
- 3 cartilage, dura mater, ligaments, tendons, pericardial tissue, or
- 4 heart valves only from a deceased individual for transplantation,
- 5 implantation, infusion, injection, or other medical or scientific
- 6 purpose.
- 7 (4) SUBJECT TO SUBSECTION (1), A LICENSEE WHO IS AN ALLOPATHIC
- 8 PHYSICIAN OR OSTEOPATHIC PHYSICIAN AND SURGEON MAY DELEGATE AN ACT,
- 9 TASK, OR FUNCTION DESCRIBED IN SUBSECTION (2) TO AN INDIVIDUAL WHO
- 10 IS NOT LICENSED UNDER THIS ARTICLE IF THE PROCEDURE IS DIRECTLY
- 11 SUPERVISED BY A LICENSED ALLOPATHIC PHYSICIAN OR OSTEOPATHIC
- 12 PHYSICIAN AND SURGEON WHO IS PHYSICALLY PRESENT DURING THE
- 13 PERFORMANCE OF THE PROCEDURE, THE DELEGATION OF SUCH PROCEDURE IS
- 14 NOT PROHIBITED OR OTHERWISE RESTRICTED BY THE BOARD OR THAT HEALTH
- 15 FACILITY OR AGENCY, AND THE DELEGATION OF THAT ACT, TASK, OR
- 16 FUNCTION IS SPECIFICALLY AUTHORIZED BY THAT HEALTH FACILITY OR
- 17 AGENCY TO BE DELEGATED AND PERFORMED BY EITHER OF THE FOLLOWING
- 18 UNLICENSED INDIVIDUALS:
- 19 (A) A SURGICAL TECHNOLOGIST WHO MEETS THE QUALIFICATIONS
- 20 ESTABLISHED BY THE HEALTH FACILITY OR AGENCY WITH WHICH HE OR SHE
- 21 IS EMPLOYED OR UNDER CONTRACT WITH.
- 22 (B) A SURGICAL FIRST ASSISTANT WHO MEETS THE QUALIFICATIONS
- 23 ESTABLISHED BY THE HEALTH FACILITY OR AGENCY WITH WHICH HE OR SHE
- 24 IS EMPLOYED OR UNDER CONTRACT WITH.
- 25 (5) -(4) A board may promulgate rules to further prohibit or
- 26 otherwise restrict delegation of specific acts, tasks, or functions
- 27 to a licensed or unlicensed individual if the board determines that

- 1 the delegation constitutes or may constitute a danger to the
- 2 health, safety, or welfare of the patient or public.
- 3 (6) $\overline{(5)}$ To promote safe and competent practice, a board may
- 4 promulgate rules to specify conditions under which, and categories
- 5 and types of licensed and unlicensed individuals for whom, closer
- 6 supervision may be required for acts, tasks, and functions
- 7 delegated under this section.
- 8 (7) $\frac{-(6)}{}$ An individual who performs acts, tasks, or functions
- 9 delegated pursuant to this section does not violate the part that
- 10 regulates the scope of practice of that health profession.
- 11 (8) THE AMENDATORY ACT THAT ADDED THIS SUBSECTION DOES NOT
- 12 REQUIRE NEW OR ADDITIONAL THIRD PARTY REIMBURSEMENT OR MANDATED
- 13 WORKER'S COMPENSATION BENEFITS FOR SERVICES RENDERED BY AN
- 14 INDIVIDUAL AUTHORIZED TO PERFORM THOSE SERVICES UNDER SUBSECTION
- 15 (4).
