

SENATE SUBSTITUTE FOR
HOUSE BILL NO. 4560

A bill to amend 1945 PA 72, entitled

"An act to prevent the importation from other states, and the spread within this state, of all serious insect pests and contagious plant diseases and to provide for their repression and control, imposing certain powers and duties on the commissioner of agriculture; to prescribe penalties for the violation of the provisions of this act; and to repeal certain acts and parts of acts,"

by amending the title and section 9 (MCL 286.259) and by adding section 10.

12 ~~discretion of the court; and the amount collected in fines shall be~~

20 (2) **BEGINNING SEPTEMBER 1, 2005, SUBSECTION (1) DOES NOT APPLY**
21 **TO A VIOLATION DESCRIBED IN SECTION 10.**

22 **SEC. 10. (1) A PERSON WHO VIOLATES A RULE PROMULGATED OR ORDER**
23 **ISSUED UNDER THIS ACT THAT REQUIRES THE DESTRUCTION OF PLANTS IS**
24 **RESPONSIBLE FOR A STATE CIVIL INFRACTION AND SHALL BE FINED NOT**
25 **MORE THAN \$1,000.00 PLUS EXPENSES INCURRED BY THE DEPARTMENT IN**
26 **DESTROYING THE PLANTS.**

27 (2) **A PERSON WHO VIOLATES A QUARANTINE RULE PROMULGATED OR**

1 QUARANTINE ORDER ISSUED UNDER THIS ACT IS RESPONSIBLE FOR A STATE
2 CIVIL INFRACTION AND SHALL BE FINED NOT LESS THAN \$1,000.00 OR MORE
3 THAN \$10,000.00. HOWEVER, IF THE PERSON VOLUNTARILY REPORTED THE
4 VIOLATION TO THE DEPARTMENT BEFORE IT WAS OTHERWISE KNOWN TO THE
5 DEPARTMENT OR THE PERSON HAD REASON TO BELIEVE THE VIOLATION WAS
6 ABOUT TO BECOME KNOWN TO THE DEPARTMENT, THE PERSON SHALL BE FINED
7 NOT MORE THAN \$500.00.

8 (3) BEGINNING SEPTEMBER 1, 2005, A PERSON WHO KNOWINGLY
9 VIOLATES A QUARANTINE RULE PROMULGATED OR QUARANTINE ORDER ISSUED
10 UNDER THIS ACT IS GUILTY OF A MISDEMEANOR AND MAY BE IMPRISONED FOR
11 NOT MORE THAN 1 YEAR AND SHALL BE FINED NOT LESS THAN \$1,000.00 OR
12 MORE THAN \$10,000.00.

13 (4) BEGINNING SEPTEMBER 1, 2005, A PERSON WHO INTENTIONALLY
14 VIOLATES A QUARANTINE RULE PROMULGATED OR QUARANTINE ORDER ISSUED
15 UNDER THIS ACT, FOR THE PURPOSE OF CAUSING DAMAGE TO PLANTS,
16 NATURAL RESOURCES, OR AGRICULTURAL, SILVICULTURAL, OR HORTICULTURAL
17 PRODUCTS OR RESOURCES, IS GUILTY OF A FELONY PUNISHABLE BY
18 IMPRISONMENT FOR NOT MORE THAN 5 YEARS OR A FINE OF NOT MORE THAN
19 \$250,000.00, OR BOTH.

20 (5) A PERSON WHO VIOLATES A QUARANTINE RULE PROMULGATED OR
21 QUARANTINE ORDER ISSUED UNDER THIS ACT IS LIABLE FOR ANY DAMAGES TO
22 PLANTS, NATURAL RESOURCES, OR AGRICULTURAL, SILVICULTURAL, OR
23 HORTICULTURAL PRODUCTS OR RESOURCES RESULTING FROM THE VIOLATION,
24 INCLUDING, BUT NOT LIMITED TO, COSTS INCURRED TO INVESTIGATE,
25 MONITOR, PREVENT, OR MINIMIZE SUCH DAMAGES.
