SUBSTITUTE FOR HOUSE BILL NO. 4623

A bill to amend 1970 PA 29, entitled

"An act relating to potatoes; to create a potato commission; to prescribe its powers and duties and authority; to impose an assessment on the privilege of introducing potatoes into the channels of trade and commerce; to provide for the collection of the assessment; to provide for penalties; and to repeal certain acts and parts of acts,"

by amending section 2 (MCL 290.422), as amended by 2000 PA 5.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 2. (1) The state potato industry commission is created
- 2 within the department. The commission shall be composed of the
- 3 director or a person designated by the director from the director's
- 4 staff, who shall serve ex officio, without vote; a staff member of
- 5 Michigan state university appointed by the dean of agriculture of
- 6 that university to serve at the pleasure of the dean, ex officio,

- 1 without vote; and 10 growers, 2 processors, 2 shippers, and 1
- 2 retailer appointed by the governor with the advice and consent of
- 3 the senate. A member appointed by the governor shall be a citizen
- 4 and resident of this state and of the district from which
- 5 appointed, shall be 18 years of age or older, and shall be in
- 6 compliance with this act. A commission member in the grower
- 7 category shall be engaged and have been engaged in growing potatoes
- 8 within this state for a period of not less than 2 years immediately
- 9 before appointment, and shall have derived a substantial portion of
- 10 his or her income from this activity.
- 11 (2) Eight growers shall be appointed to serve on the
- 12 commission, representing 7 districts throughout the state as
- 13 follows: District 1--Upper Peninsula counties shall be represented
- 14 by 2 members. The following districts shall be represented by 1
- 15 member each: district 2--Antrim, Manistee, Wexford, Missaukee,
- 16 Roscommon, Mason, Lake, Osceola, Clare, Benzie, Charlevoix,
- 17 Cheboygan, Crawford, Emmet, Grand Traverse, Kalkaska, Leelanau, and
- 18 Otsego; district 3--Alcona, Alpena, Montmorency, Oscoda, Presque
- 19 Isle, Iosco, and Ogemaw; district 4--Kent, Montcalm, Newaygo,
- 20 Isabella, Mecosta, and Oceana; district 5--Bay, Arenac, Midland,
- 21 Tuscola, Huron, Sanilac, Gratiot, Gladwin, and Saginaw; district 6-
- 22 -Allegan, Barry, Eaton, Van Buren, Kalamazoo, Calhoun, Berrien,
- 23 Cass, Clinton, Ionia, Ottawa, Muskegon, St. Joseph, and Branch;
- 24 district 7--Ingham, Livingston, Oakland, Macomb, Jackson,
- 25 Washtenaw, Wayne, Hillsdale, Lenawee, Shiawassee, Genesee, Lapeer,
- 26 St. Clair, and Monroe. The ninth and tenth growers shall serve at
- 27 large. The other members of the commission, except the ex officio

- 1 members, shall have been associated with the potato industry for
- 2 not less than 2 years immediately before appointment.
- 3 (3) The term of office of an appointed member shall be 3
- 4 years. The term of an appointed member shall expire on July 1,
- 5 except that a term shall continue until a successor is appointed
- 6 and qualified. If during a term a member ceases to possess any of
- 7 the qualifications prescribed in this act, that member's office
- 8 shall be vacated. A person appointed to fill a vacancy shall serve
- 9 for the remainder of the unexpired term and until a successor is
- 10 appointed and qualified.
- 11 (4) The commission shall conduct a meeting of growers and
- 12 shippers annually.
- 13 (5) The commission may conduct a meeting of growers in the
- 14 district where a vacancy will occur by expiration of a term, to
- 15 elect nominees for appointment to the commission. Instead of a
- 16 meeting, nominees may be selected by a vote of growers in the
- 17 district by mail ballot, providing ballots are mailed by the
- 18 commission to all growers of record, and in compliance with this
- 19 act. Not more than 2 nominees for each vacancy on the commission
- 20 shall be selected. The names of all nominees shall be placed on a
- 21 list of nominees recommended to the governor, and the governor
- 22 shall make appointments from that list. The growers at large shall
- 23 be nominated by a majority of the 8 growers representing the
- 24 districts. A majority of the 10 grower members shall nominate the
- 25 processor, shipper, and retail candidates for appointment to the
- 26 commission. Vacancies on the commission, except from the expiration
- 27 of term, shall be filled by the governor from nominees selected by

- 1 the commission. A person appointed as a commission member shall
- 2 qualify by filing a written acceptance and oath of office within 10
- 3 days after being notified by the governor of the appointment.
- 4 (6) Annually, the commission members shall elect a chairperson
- 5 from among its appointed members. A majority of the voting members
- 6 of the commission constitutes a quorum for the transaction of
- 7 business and the carrying out of the duties of the commission. The
- 8 business which the commission may perform shall be conducted at a
- 9 public meeting of the commission held in compliance with the open
- 10 meetings act, 1976 PA 267, MCL 15.261 to 15.275. Public notice of
- 11 the time, date, and place of the meeting shall be given in the
- manner required by the open meetings act, 1976 PA 267, MCL 15.261
- 13 to 15.275. Meetings of the commission shall be called by the
- 14 chairperson, except that special meetings shall be called by the
- 15 chairperson on petition of 8 members no later than 7 days after
- 16 receiving the petition.
- 17 (7) THE COMMISSION, WITH THE ADVICE AND CONSENT OF THE
- 18 DIRECTOR AND THE COMMISSION OF AGRICULTURE, MAY REAPPORTION EITHER
- 19 THE NUMBER OF COMMISSION MEMBERS OR MEMBER DISTRICTS, OR BOTH.
- 20 REAPPORTIONMENT OF THE DISTRICTS SHALL BE ON THE BASIS OF
- 21 PRODUCTION OR INDUSTRY REPRESENTATION. REAPPORTIONMENT MAY BE
- 22 COMMENCED NOT EARLIER THAN 30 DAYS AFTER THE EFFECTIVE DATE OF THE
- 23 AMENDATORY ACT THAT ADDED THIS SUBSECTION. REAPPORTIONMENT OF
- 24 EITHER MEMBERS OR DISTRICTS SHALL NOT OCCUR MORE THAN TWICE IN ANY
- 25 5-YEAR PERIOD AND SHALL NOT OCCUR WITHIN 6 MONTHS BEFORE A
- 26 REFERENDUM. AFTER REAPPORTIONMENT UNDER THIS SUBSECTION, IF THE
- 27 RESIDENCE OF A MEMBER OF THE COMMISSION FALLS OUTSIDE THE DISTRICT

- 1 FOR WHICH HE OR SHE SERVES ON THE COMMISSION AND FALLS WITHIN THE
- 2 DISTRICT FOR WHICH ANOTHER MEMBER SERVES ON THE COMMISSION, THEN
- 3 BOTH MEMBERS SHALL CONTINUE TO SERVE ON THE COMMISSION FOR A TERM
- 4 EQUAL TO THE REMAINING TERM OF THE MEMBER WHO SERVED FOR THE
- 5 LONGEST PERIOD OF TIME. AFTER THE REAPPORTIONMENT DESCRIBED IN THIS
- 6 SUBSECTION, IF A DISTRICT IS CREATED WITHIN WHICH NO MEMBER SERVING
- 7 ON THE COMMISSION RESIDES, THAN A MEMBER SHALL BE SELECTED IN THE
- 8 MANNER AS PRESCRIBED IN THIS SECTION. AFTER A REAPPORTIONMENT OR
- 9 REDISTRICTING, THE COMMISSION MAY TEMPORARILY HAVE MORE MEMBERS
- 10 THAN PRESCRIBED BY THIS SECTION UNTIL THE EXPIRATION OF THE TERM OF
- 11 THE LONGEST-SERVING MEMBER FROM THAT DISTRICT. IN THE CASE OF A
- 12 REAPPORTIONMENT CONDUCTED UNDER THIS SUBSECTION, THE PROVISIONS OF
- 13 THIS SUBSECTION PREVAIL OVER ANY OTHER CONFLICTING PROVISIONS OF
- 14 THIS SECTION.
- 15 (8) -(7)— The per diem compensation of the appointed members
- 16 of the commission shall not exceed \$75.00 plus the reimbursement of
- 17 expenses incurred in attending a commission meeting.
- 18 (9) -(8) All funds of the commission shall be handled by the
- 19 commission and all funds received by it shall be used to implement
- 20 this act. Money received by the commission shall be deposited in
- 21 banks or other forms of security as may be designated by the
- 22 commission.
- (10) $\overline{(9)}$ Retailers, processors, and others may support the
- 24 programs of the commission by paying an annual fee of \$100.00.
- 25 (11) -(10)— The commission may accept gifts and grants.
- 26 (12) $\frac{}{}$ The commission shall maintain accurate books,
- 27 records, and accounts of its transactions, which books, records,

- 1 and accounts shall be open to inspection by the public and shall be
- 2 subject to audit by the auditor general or a certified public
- 3 accountant. A document prepared, owned, used, in the possession of,
- 4 or retained by the commission in the performance of an official
- 5 function shall be made available to the public in compliance with
- 6 the freedom of information act, 1976 PA 442, MCL 15.231 to 15.246,
- 7 except as otherwise provided in section 4a.
- 8 (13) -(12)— The commission may borrow money in anticipation of
- 9 the receipt of assessments if all of the following conditions are
- **10** met:
- 11 (a) The loan will not be requested or authorized, or will not
- 12 mature, within 90 days before a resubmittal or termination
- 13 referendum regarding an assessment under this act.
- 14 (b) The amount of the loan does not exceed 50% of the annual
- 15 average assessment revenue during the previous 3 years.
- 16 (c) The loan repayment period does not exceed the time period
- 17 during which the assessment is made or the time period during which
- 18 the assessment can reasonably be expected to be imposed.
- 19 (d) The loan has the prior written consent of the director.
- 20 The director may request an audit of the commission by the auditor
- 21 general before approving the loan.
- 22 (14) $\frac{(13)}{}$ The director shall assess against the growers and
- 23 shippers all outstanding loans approved under subsection $\frac{12}{12}$
- 24 (13), including interest, if the assessment is terminated.
- 25 (15) -(14) A financial report shall be prepared annually and
- 26 made available upon request.
