SENATE SUBSTITUTE FOR HOUSE BILL NO. 4670

A bill to amend 1978 PA 368, entitled "Public health code,"

(MCL 333.1101 to 333.25211) by adding section 16184.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 16184. (1) AN INDIVIDUAL WHO IS RETIRED FROM THE ACTIVE
- 2 PRACTICE OF MEDICINE, OSTEOPATHIC MEDICINE AND SURGERY, OR
- 3 PODIATRIC MEDICINE AND SURGERY AND WHO WISHES TO DONATE HIS OR HER
- 4 EXPERTISE FOR THE MEDICAL CARE AND TREATMENT OF INDIGENT AND NEEDY
- 5 INDIVIDUALS IN THIS STATE OR FOR THE MEDICAL CARE AND TREATMENT OF
- 6 INDIVIDUALS IN MEDICALLY UNDERSERVED AREAS OF THIS STATE MAY OBTAIN
- 7 A SPECIAL VOLUNTEER LICENSE TO ENGAGE IN THE PRACTICE OF MEDICINE,
- 8 OSTEOPATHIC MEDICINE AND SURGERY, OR PODIATRIC MEDICINE AND SURGERY
- 9 BY SUBMITTING AN APPLICATION TO THE BOARD PURSUANT TO THIS SECTION.

- 1 AN APPLICATION FOR A SPECIAL VOLUNTEER LICENSE SHALL BE ON A FORM
- 2 PROVIDED BY THE DEPARTMENT AND SHALL INCLUDE EACH OF THE FOLLOWING:
- 3 (A) DOCUMENTATION THAT THE INDIVIDUAL HAS BEEN PREVIOUSLY
- 4 LICENSED TO ENGAGE IN THE PRACTICE OF MEDICINE, OSTEOPATHIC
- 5 MEDICINE AND SURGERY, OR PODIATRIC MEDICINE AND SURGERY IN THIS
- 6 STATE AND THAT HIS OR HER LICENSE WAS IN GOOD STANDING PRIOR TO THE
- 7 EXPIRATION OF HIS OR HER LICENSE.
- 8 (B) ACKNOWLEDGMENT AND DOCUMENTATION THAT THE APPLICANT WILL
- 9 NOT RECEIVE ANY PAYMENT OR COMPENSATION, EITHER DIRECT OR INDIRECT,
- 10 OR HAVE THE EXPECTATION OF ANY PAYMENT OR COMPENSATION, FOR ANY
- 11 MEDICAL CARE SERVICES PROVIDED UNDER THE SPECIAL VOLUNTEER LICENSE.
- 12 (C) IF THE APPLICANT HAS BEEN OUT OF PRACTICE FOR 3 OR MORE
- 13 YEARS, DOCUMENTATION THAT, DURING THE 3 YEARS IMMEDIATELY PRECEDING
- 14 THE APPLICATION, HE OR SHE HAS ATTENDED AT LEAST 2/3 OF THE
- 15 CONTINUING EDUCATION COURSES OR PROGRAMS REQUIRED UNDER PART 170,
- 16 175, OR 180 FOR THE RENEWAL OF A LICENSE.
- 17 (2) IF THE BOARD DETERMINES THAT THE APPLICATION OF THE
- 18 INDIVIDUAL SATISFIES THE REQUIREMENTS OF SUBSECTION (1) AND THAT
- 19 THE INDIVIDUAL MEETS THE REQUIREMENTS FOR A LICENSE AS PRESCRIBED
- 20 BY THIS ARTICLE AND RULES PROMULGATED UNDER THIS ARTICLE, THE BOARD
- 21 SHALL GRANT A SPECIAL VOLUNTEER LICENSE TO THE APPLICANT. A
- 22 LICENSEE SEEKING RENEWAL UNDER THIS SECTION SHALL PROVIDE THE BOARD
- 23 WITH AN UPDATED ACKNOWLEDGMENT AND DOCUMENTATION AS DESCRIBED UNDER
- 24 SUBSECTION (1)(B). EXCEPT AS OTHERWISE PROVIDED UNDER THIS
- 25 SUBSECTION, THE BOARD SHALL NOT CHARGE A FEE FOR THE ISSUANCE OR
- 26 RENEWAL OF A SPECIAL VOLUNTEER LICENSE UNDER THIS SECTION.
- 27 (3) EXCEPT AS OTHERWISE PROVIDED UNDER THIS SUBSECTION, AN

- 1 INDIVIDUAL WHO IS GRANTED A SPECIAL VOLUNTEER LICENSE PURSUANT TO
- 2 THIS SECTION AND WHO ACCEPTS THE PRIVILEGE OF PRACTICING MEDICINE,
- 3 OSTEOPATHIC MEDICINE AND SURGERY, OR PODIATRIC MEDICINE AND SURGERY
- 4 IN THIS STATE IS SUBJECT TO ALL OF THE PROVISIONS OF THIS ARTICLE,
- 5 INCLUDING THOSE PROVISIONS CONCERNING CONTINUING EDUCATION AND
- 6 DISCIPLINARY ACTION.
- 7 (4) FOR PURPOSES OF THIS SECTION, AN INDIVIDUAL IS CONSIDERED
- 8 RETIRED FROM PRACTICE IF THE INDIVIDUAL'S LICENSE HAS EXPIRED WITH
- 9 THE INDIVIDUAL'S INTENTION OF CEASING TO ENGAGE IN THE PRACTICE OF
- 10 MEDICINE, OSTEOPATHIC MEDICINE AND SURGERY, OR PODIATRIC MEDICINE
- 11 AND SURGERY FOR REMUNERATION.
