THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- Sec. 1. (1) The children's trust fund is created as a charitable and educational endowment fund in the department of treasury. The fund shall be expended only as provided in this section.
- (2) The state treasurer shall credit to the trust fund all amounts appropriated for this purpose under section 475 of the income tax act of 1967, 1967 PA 281, MCL 206.475, any amounts received under section 811j of the Michigan vehicle code, 1949 PA

- 1 (6) The state treasurer shall annually prepare an accounting
- 2 of revenues and expenditures from the trust fund. This accounting
- 3 shall specifically identify the interest and earnings of the trust
- 4 fund, shall describe how the amount of interest and earnings has
