- 3 UNDER SECTION 16184 IS NOT LIABLE IN A CIVIL ACTION FOR PERSONAL
- 4 INJURY OR DEATH PROXIMATELY CAUSED BY THE PROFESSIONAL NEGLIGENCE
 - OR MALPRACTICE OF THE PHYSICIAN IN PROVIDING THE CARE IF BOTH OF
 - THE FOLLOWING APPLY:
- 7 (A) THE CARE IS PROVIDED AT A HEALTH FACILITY OR AGENCY THAT
- 8 PROVIDES AT LEAST 75% OF ITS CARE ANNUALLY TO MEDICALLY INDIGENT
