THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 63203. (1) The department shall administer and enforce
- 2 this part in order to regulate nonferrous metallic mineral mining.
- 3 In addition to other powers granted to it, the department may
- 4 promulgate rules it considers necessary to carry out its duties
- 5 under this part, including standards for construction, operation,
- 6 closure, postclosure monitoring, reclamation, and remediation of a
- 7 nonferrous metallic mineral mine. However, the department shall not
- 8 promulgate any additional rules under this part after December 31,
- 9 2005 << FEBRUARY 15>>, 2006.

- 1 (2) The department may do either of the following:
- 2 (a) Enter at all reasonable times in or upon a mining area for
