SUBSTITUTE FOR HOUSE BILL NO. 5603

A bill to amend 1978 PA 368, entitled "Public health code,"

(MCL 333.1101 to 333.25211) by adding section 5141.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 5141. (1) UPON APPROPRIATION OF THE NECESSARY FUNDING TO
- 2 SUPPORT THE WORK GROUP AND THE EDUCATION PROGRAM, THE DEPARTMENT
- 3 SHALL ESTABLISH A REFLEX SYMPATHETIC DYSTROPHY/COMPLEX REGIONAL
- 4 PAIN SYNDROME (RSD/CRPS) WORK GROUP THAT IS COMPOSED OF BOTH PUBLIC
- 5 AND PRIVATE SECTOR MEMBERS. THE RSD/CRPS WORK GROUP, IN
- 6 CONSULTATION WITH HEALTH CARE PROVIDERS AND HEALTH-RELATED
- 7 ORGANIZATIONS, SHALL DEVELOP AND COORDINATE AN RSD/CRPS EDUCATION
- 8 PROGRAM TO PROMOTE PUBLIC AWARENESS OF THE CAUSES OF RSD/CRPS AND
- 9 THE VALUE OF EARLY DETECTION, DIAGNOSIS, AND TREATMENT OF THIS
- 10 DISEASE. THE RSD/CRPS PROGRAM SHALL INCLUDE A PUBLIC EDUCATION AND

- 1 OUTREACH CAMPAIGN UTILIZING WRITTEN MATERIALS AND BROCHURES TO
- 2 PROMOTE AWARENESS OF RSD/CRPS AMONG CONSUMERS, HEALTH CARE
- 3 PROVIDERS, TEACHERS, AND HUMAN SERVICES PROVIDERS AND TO ENABLE
- 4 INDIVIDUALS TO MAKE INFORMED DECISIONS ABOUT THEIR HEALTH. THE
- 5 WRITTEN MATERIALS AND BROCHURES SHALL INCLUDE, BUT ARE NOT LIMITED
- 6 TO, INFORMATION REGARDING EACH OF THE FOLLOWING:
- 7 (A) CAUSE AND NATURE OF RSD/CRPS.
- 8 (B) RISK FACTORS THAT CONTRIBUTE TO THE MANIFESTATION OF
- 9 RSD/CRPS.
- 10 (C) ALL AVAILABLE TREATMENT OPTIONS FOR RSD/CRPS INCLUDING THE
- 11 RISKS AND BENEFITS OF EACH OF THOSE OPTIONS.
- 12 (D) ENVIRONMENTAL SAFETY AND INJURY PREVENTION.
- 13 (E) REST AND USE OF APPROPRIATE BODY MECHANICS.
- 14 (F) ANY OTHER INFORMATION THAT IS RELEVANT TO RSD/CRPS.
- 15 (2) THE EDUCATIONAL MATERIALS AND BROCHURES DEVELOPED UNDER
- 16 SUBSECTION (1) SHALL BE MADE AVAILABLE TO THE PUBLIC THROUGH THE
- 17 DEPARTMENT'S WEBSITE OR HEALTH PROMOTIONS CLEARINGHOUSE HOTLINE
- 18 AND, IF SUFFICIENT FUNDING IS AVAILABLE, THE EDUCATIONAL MATERIALS
- 19 AND BROCHURES SHALL BE DISTRIBUTED TO LOCAL HEALTH DEPARTMENTS,
- 20 HOSPITALS, AND HEALTH CARE PROVIDERS FOR DISTRIBUTION TO THE
- 21 PUBLIC. THE RSD/CRPS WORK GROUP SHALL ALSO FACILITATE AS A PART OF
- 22 THE RSD/CRPS PROGRAM EDUCATIONAL WORKSHOPS THAT ARE OPEN TO THE
- 23 PUBLIC. THE WORKSHOPS SHALL INCLUDE, AT A MINIMUM, AT LEAST 1
- 24 PHYSICIAN PRESENTER WHO IS LICENSED UNDER ARTICLE 15 AND IS
- 25 KNOWLEDGEABLE ABOUT RSD/CRPS.
- 26 (3) THE DEPARTMENT MAY ACCEPT AND UTILIZE FEDERAL OR STATE
- 27 FUNDS OR OTHER PUBLIC OR PRIVATE GRANTS, GIFTS, DONATIONS, OR

- 1 APPROPRIATIONS TO CARRY OUT THE PURPOSES OF THIS SECTION,
- 2 INCLUDING, BUT NOT LIMITED TO, PROMOTING RESEARCH TO ACCURATELY
- 3 IDENTIFY, DIAGNOSE, AND TREAT THIS DISEASE.
