- 4 UNDER THE SUPERVISION OF OR FOR THE BENEFIT OF THE PERSON,
- 5 INCLUDING, BUT NOT LIMITED TO, COMMERCIAL SEXUAL ACTIVITY AND
- 6 SEXUALLY EXPLICIT PERFORMANCES.

- 26 PROVIDE, OR OBTAIN BY ANY MEANS, ANOTHER PERSON, INTENDING OR
- 27 KNOWING THAT THE PERSON WILL BE SUBJECTED TO FORCED LABOR OR

- (B) BENEFIT FINANCIALLY OR RECEIVE ANYTHING OF VALUE FROM 2

- SEC. 4621. IF A VIOLATION OF THIS CHAPTER INVOLVES KIDNAPPING 14
- 15 OR AN ATTEMPT TO KIDNAP, CRIMINAL SEXUAL CONDUCT OR AN ATTEMPT TO
- COMMIT CRIMINAL SEXUAL CONDUCT, OR AN ATTEMPT TO KILL, THE 16
- 17 DEFENDANT SHALL BE IMPRISONED FOR LIFE OR ANY TERM OF YEARS.
- 18 Enacting section 1. This amendatory act takes effect 90 days
- 19 after the date it is enacted.
